MEMORANDUM FOR THE CHIEF OF STAFF

Under the authority of Section 1552, Title 10, United States Code and Air Force Instruction 36-2603, and having assured compliance with the provisions of the above regulation, the decision of the Air Force Board for Correction of Military Records is announced, and it is directed that:


The pertinent military records of the Department of the Air Force relating to [REDACTED] be corrected to show that:

a. On 3 June 1997, he was designated a chaplain, Reserve of the Air Force and was extended Federal recognition in the grade of lieutenant colonel.

b. On 30 June 1997, he requested a waiver of his Mandatory Separation Date and his request was approved by competent authority pursuant to Title 10, United States Code, Section 14703, thereby establishing a new Mandatory Separation Date of 7 July 2002.

c. He was not discharged from the [REDACTED] Air National Guard on 7 July 1997 and transferred to the Air Force Reserve, effective 8 July 1997, but was continued as an active member of the [REDACTED] Air National Guard and the Reserve of the Air Force.

d. He was credited with an additional 35 paid active duty points, 57 paid inactive duty points and 15 membership points during the retirement/retention year 7 June 1997 through 6 June 1998, resulting in 107 total points; and, that the period 7 June 1997 through 6 June 1998 is a satisfactory year of Federal service.

This memorandum responds to your March 24, 1998 request for a SAFPC opinion on subject case.

Title 10 USC, Section 14703 authorizes the Secretary of the ~~Air~~ Force to retain chaplains until a specified age. Chaplain retention cases submitted to the SAFPC are normally approved when the member's chain of command supports and justifies the member's retention as being in the best interest of the ~~Air~~ Force. Subject case would have received favorable consideration by the SAF Personnel Board if it had been submitted in a timely manner.

The attached Application for Correction of Military Records submitted by the applicant, a former member of the [REDACTED] Air National Guard, is forwarded for your review and comments.

The applicant requests an extension to the mandatory separation date (MSD) and appointment as a chaplain.


This Headquarters recommends relief. We have reviewed HQ ARPC/DPAD letter, as requested. The [REDACTED] Air National Guard provided supporting documentation to justify the selection of the applicant for their chaplain position. Through no fault of the applicant, the reappointment application was not received at ANG/MPPS in sufficient time to grant approval and request Secretary of the Air Force Approval for extension of the MSD.

We realize the administrative burdens required to remove the applicant from the Retired Reserve, however, we do not feel that is sufficient justification to deny relief. TAG [REDACTED] has supported the applicant's reappointment and extension of MSD based on the critical need for chaplains in the ANG. They are currently authorized three chaplains – one position is vacant and the other two chaplains will be retiring in the near future.

Failure to recommend relief would result in a serious injustice to the applicant and the [REDACTED] Air National Guard.

This Headquarters recommends relief. We support the applicant's request for appointment as a professional officer (Chaplain) and we support the applicant's request for extension of MSD. Although supporting documentation from the [REDACTED] ANG does not explain the delay in processing the applicant's reappointment application, we believe there is merit to this case. We believe the timely processing of the MSD extension was not the fault of the applicant, and therefore an injustice occurred. Our recommendation has been coordinated with the Air National Guard Chaplain's Office.
