## MEMORANDUM FOR THE CHIEF OF STAFF

Under the authority of Section 1552, Title 10, United States Code and Air Force Instruction 36-2603, and having assured compliance with the provisions of the above regulation, the decision of the Air Force Board for Correction of Military Records is announced, and it is directed that:

The pertinent military records of the Department of the Air Force relating to be corrected to show that:

- a. He was not discharged on 1 February 1998, and, his reenlistment in the Regular Air Force on 2 February 1998 for-a period of six (6) years, be, and hereby is, declared void.
- b. He was honorably discharged on 2 February 1998 and reenlisted in the Regular Air Force on 3 February 1998 for a period of six (6) years; and, at the time of his reenlistment on 3 February 1998, he was entitled to a zone A, multiple three Selective Reenlistment Bonus (SRB), with obligated service through 1 February **1999**.

The applicant is requesting his 2 Feb 98 reenlistment be changed to 3 Feb 98. **This** will allow him to collect a Zone A Selective Reenlistment **Bonus** (SRB) in the pay grade of E-4.

The applicant was erroneously advised to reenlist on 2 Feb 98 in order to receive an SRB in the pay grade of E-4. The SRB is paid based on the date of discharge, as specified in **DoD** Pay **Manual**, paragraph 10912. **In this case**, the applicant's discharge date was 1 Feb 98, one day short of obtaining the E-4 grade. As such, we recommend the applicant's reenlistment on 2 Feb 98 be voided. A constructive reenlistment should be granted effective 3 Feb 98 for six **years**. The AF **Form** 901, Reenlistment Eligibility **Annex** to DD Form **4**, Section III(D) should reflect an SRB Zone A, Mult 3, payable for five years and zero months. **The** applicant is not entitled to the full **six years** due to obligated service he had based on a separation date of 1 Feb 99.
