Under the authority of Section 1552, Title 10, United States Code and Air Force Instruction 36-2603, and having assured compliance with the provisions of the above regulation, the decision of the Air Force Board for Correction of Military Records is announced, and it is directed that:

The pertinent military records of the Department of the Air Force relating to be corrected to show that:

- a. He was not released from active duty and transferred to the Air Force Reserve on 20 August 1997 but was continued on active duty and was ordered permanent change of station to his home of record (home of selection) pending further orders.
- b. He received an approved Career Job Reservation (CJR) in Air Force Specialty Code (AFSC) 3E0X2, with no Selective Reenlistment Bonus (SRB); and, he was honorably discharged effective 16 November 1997 and, on 17 November 1997, he reenlisted in the Regular Air Force for a period of 4 years.


