SUBJECT: Application for Correction of Military Record

The applicant requests a constructive reenlistment to enable her to retire the first day of the month following High Year of Tenure (HYT). She filed a timely request within three years of discovering the alleged injustice.

Title 10, USC 509 restricts an airman from extending any one enlistment in excess of **48** months. The applicant extended her 31 Aug 90 (five-year) enlistment a total of 38 months. He needs an additional 38 months to retire effective 1 Jan 2000. We give this date since it is the first day of the month following the applicant's HYT month of Dec 1999.

We recommend the applicant be given relief by granting her a two-year, 1 Jan 1998 constructive reenlistment. This would establish her date of separation as 31 Dec 1999 and allow her to retire effective 1 Jan 2000.
