MEMORANDUM FOR THE CHIEF OF STAFF

Under the authority of Section 1552, Title 10, United States Code, Air Force **Instruction** 36-2603, and having assured compliance with the provisions of the above regulation, the decision of the Air Force Board for Correction of Military Records is announced, and it is directed that:

The pertinent military records of the Department of the Air Force relating to [REDACTED] [REDACTED] be corrected to show that she was honorably discharged on 16 February 1998 rather than 16 April 1998 and reenlisted in the Regular Air Force on 17 February 1998 rather than 17 April 1998 for a period of six (6) years, with entitlement to a zone A, multiple ½ Selective Reenlistment Bonus (SRB), payable for five (5) years.





SUBJECT: Application for Correction of Military Records

The applicant is requesting cancellation of her 17 Apr 98 reenlistment and a constructive reenlistment be granted effective 17 Feb 98 with subsequent entitlement to a Selective Reenlistment Bonus (SRB).

On 21 Jan 98, HQ USAF/DPXPS announced SRB changes which deleted the applicant's SRB effective 20 Feb 98. The Military Personnel Flight failed to notify the applicant of her eligibility, thereby missing her window of opportunity. As a result, the applicant reenlisted on 17 Apr 98 with no SRB entitlement.

We recommend the 17 Apr 98 reenlistment be voided. A constructive reenlistment should be granted effective 17 Feb 98 for six years. The AF Form 901, Reenlistment Eligibility Annex to DD Form 4, Section III(D) should reflect an SRB Zone A, Mult ½, payable for five years and zero months. The applicant is not entitled to the full six years due to obligated service she already had based on an original separation date of 15 Feb 99.
