This Headquarters recommends relief. After review of Air National Guard Instruction ANGI 36-2002 (Enlistment and Reenlistment in the Air National Guard and as a Reserve of the Air Force) and ANGI 36-2502 (Promotion of Airmen, Air National Guard), we believe the applicant should be entitled to be credited with the time previously served in a higher grade. The applicant's DOR should be adjusted to give her credit for two years and eleven months previously served in the grade of E-5, which would be 1Feb 95, with an effective date of 1 Jan 98.
