
RECORD OF PROCEEDINGS AIR FORCE BOARD FOR CORRECTION OF MILITARY RECORDS

Applicant requests that his discharge be upgraded to honorable. Applicant's submission is at Exhibit A.

The Air Force Discharge Review Board (AFDRB) denied applicant's request on 22 January **1998.** In accordance with policy, the application was forwarded to this Board for further consideration (Exhibit C). The AFDRB brief was forwarded to applicant for review and response (Exhibit D). Applicant's response is at Exhibit E.

After careful consideration of applicant's request and the available evidence of record, we find insufficient evidence of error or injustice to warrant corrective action. The facts and opinions stated in the AFDRB brief appear to be based on the evidence of record and have not been rebutted by applicant. Absent persuasive evidence applicant was denied rights to wh^{ich} entitled, appropriate regulations were not followed, or appropriate standards were not applied, we find no basis to disturb the existing record.

Accordingly, applicant's request is denied.

The Board staff is directed to inform applicant of this decision. Applicant should also be informed that this decision is final and will only be reconsidered upon the presentation of new relevant evidence which was not reasonably available at the time the application was filed.

SUBJECT: Notification Memorandum

1. I am recommending your discharge from the United States Air Force for Misconduct • Drug Abuse. The authority for this action is AFPD 36-32 and AFI 36-3208, paragraph 5.54. If my recommendation is approved, your service could be characterized as honorable or general. I am recommending that your service be characterized as general.

2. My reason for this action is as follows:

On 12 Jan 97, you provided a urine sample for drug testing purposes which tested positive for marijuana (Atch 1). For this incident you received an Article 15, dated 11 Mar 97 (Atch 2).

3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or higher authority will decide whether you will be discharged or retained in the Air Force.

4. You have the right to consult coursel. Military legal counsel has been obtained to assist you I have made an appointment for you to consult Capt **Humanitary Human**, Area Defense Counsel, Brilding 3112, Room 155, **WEATHER**, on <u>13 MART</u> at <u>1400 Krs</u>. You may consult civilian coursel at your own expense.

5. You have the right to submit statements in your own behalf. Any statements you want the Separation authority to consider must reach me by (3 duty days) <u>18Mar</u> 97, unless you request and receive an extension for good cause shown. I will send them to the separation authority.

6. If you fail **to** consult counsel or to submit statements in **your own behalf**, **your** failure will constitute a waiver of your right to do **so**.

7. Youhavebeenscheduled for a medical examination. You must report to the Physical Examination Section, Medical Group, Building 3349, at Oso on 13 (AR17 for the examination.

8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in your orderly room.
