The pertinent military records of the Department of the Air Force relating to [REDACTED], be corrected to show that he was credited with an additional 4 non-paid Inactive Duty Training (IDT) points during the retirement/retention year 16 April 1997 through 15 April 1998, resulting in 5 active duty (AD) points, 30 IDT points and 15 membership points for a total of 50 points; and, that the period 16 April 1997 through 15 April 1998 is a year of satisfactory Federal service.

1. The requested action cannot be accomplished administratively at this headquarters.
2. The applicant is requesting 4 points be added to participation record to enable to have a satisfactory year of Federal service for the Retention/Retirement (R/R) year 16 April 1997 to 15 April 1998 [REDACTED]
3. The following is an analysis of the circumstances surrounding this case:
 - a. Last year the applicant accepted a position with the Federal government as a custom's agent. Upon acceptance of this position was scheduled to attend school from May 1997 to August 1997.
 - b. The applicant claims prior to the attendance of school, reviewed record to ensure the time was away would not prohibit, attaining all the points needed for a satisfactory year of Federal service for the R/R year 16 April 1997 to 15 April 1998. The Unit Training Assembly (UTA) for April 1997 was scheduled for 5-6 April. The applicant was aware these points would not be credited in the 16 April 1997 - 15 April 1998 R/R year. The April 1998 UTA was scheduled for 4-5 April 1998 and then was rescheduled for 25-26 April 1998. The applicant had planned on attending the 4-5 April UTA to complete R/R year requirements. Since it was rescheduled for dates after R/R year closed out, was not credited with the 4 points needed to fulfill R/R year requirement.
 - c. The applicant has been an active participant until this year when civilian job responsibilities interfered. Attached is a computer printout showing a year-by-year breakdown of the applicant's past point history [REDACTED]. Since had not planned on the April UTA being rescheduled, believes should be credited with the 4 points would have received if the UTA had remained as originally scheduled.

4. Recommend **this** application be approved. The applicant was aware of the situation when accepted the civilian position and made an honest effort to fulfill R/R year requirements. The applicant planned schedule accordingly. Through no fault of own, the last **UTA** could have performed to fulfill R/R year requirements was rescheduled. The member's R/R year would not have been determined by one weekend drill if the circumstances were normal. In past R/R years the applicant has earned far above the required amount of points that determine a satisfactory year of Federal service. If this application is approved the following corrective action would be necessary. For retirement year ending (RYE) **15 April 1998**, award **4** non-paid Inactive Duty Training (IDT) points. The applicant's record would then show **5** active duty points, **30** IDT points, **0** Extension Course Institute points, **15** membership points, **50** total and retirement points **and** a year of satisfactory Federal service.
