

AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

GENERAL: The applicant appeals for upgrade of discharge to Honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains the available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds that neither evidence of record nor that provided by the applicant substantiates an inequity or impropriety which would justify a change of discharge.

The applicant's issues are listed in the attached brief.

Issue applies to the applicant's post-service activities. The DRB was pleased to see that the applicant was doing well and has a good job. However, no inequity or impropriety in his discharge was found in the course of the hearing. The records indicated the applicant received two Article 15s, a Letter of Reprimand, two Letters of Counseling, and four Records of Individual Counseling for misconduct. The misconduct included being late for duty on several occasions, dereliction in the performance of his duties, leaving his appointed place of duty without authority, and failing to maintain sufficient fund in his bank account to cover checks he wrote. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

SUBJECT: Legal Review of AFPD 36-32 and AFI 36-3208 Discharge Action -

SrA , 354 CS, PACAF

1. I have reviewed the discharge package of SrA discontinuous and find it legally sufficient to support the proposed action. I concur with the recommendation of the unit commander that SrA eceive a general discharge without probation and rehabilitation based on Misconduct-Minor Disciplinary Infractions, AFI 36-3208, under the provisions of paragraph **5.49**.

2. **DISCUSSION**:

The following incidents form the basis for this action:

- a. On or about 16 Mar 99, he was late for duty. For this infraction, he received a Letter of Counseling, dated 16 Mar 99 (Tab 4, Atch 1).
- b. On **or** about 30 Mar 99, he was late for duty. For this infraction, he received a Letter of Counseling, dated **30** Mar 99 (**Tab 4**, Atch **2**).
- c. On or about 13 and 14 May 99, he was derelict in the performance of his duty by not taking out the **trash** as assigned to do so. For this infraction, he received a Letter of Counseling on **14** May.99 (Tab **4**, Atch 3).
- d. On **or** about 2 Sep 99, he **was** late for duty. For this infraction, he received a Letter of Counseling, dated 2 Sep 99 (Tab 4, Atch 4).
- e. On **or** about 1 Oct 99, he **was** late for duty. For this infraction, he received a Letter **of** Counseling, dated 1 Oct 99 (Tab **4**, Atch 5).
- **f.** Between on or about 26 Aug 99 and 1 Oct 99, he was derelict in the performance of his duty by negligently failing to complete the Technical **Order** annual **A** page check by the prescribed date. Betweenon or about 27 Sep 99 and 1 Oct 99, he was derelict **in** the performance of his duty by failing to sign the vehicle AF Form 1800, not locking the vehicle after being told

to do so while not driving it, arriving for **work** 50 minutes late, leaving for TDY without processing out of the squadron Orderly Room, and not informing his work center of his **TDY** billeting room telephone number. For these infractions, he received a Letter of Reprimand, dated 25 Oct *99* (Tab **4,Atch** *6*).

- g. On or about 4 Nov 99, he was counseled on his responsibilities in the work center. For this, he received a Letter of Counseling, dated 4 Nov 99 (Tab 4, Atch 7).
- h. On or about 12 Nov **99**, he left his appointed place of duty without authority. For **this** infraction, he received an Article 15, dated 22 Nov **99** (Tab **4**, Atch 8).
- i. On or about 11 Jan 00, he dishonorably failed to maintain sufficient funds in his bank account to cover checks he wrote. For this infraction he received an Article 15, dated 17 Apr 00 (Tab 4, Atch 9).
- 3. All procedures required by AFI 36-3208 have been properly complied with, and the case has been appropriately processed. That waived his rights to consult legal counsel and to submit matters for your consideration (Tab 6).
- 4. IRREGULARITIES: None.
- 5. OPTIONS FOR THE SPECIAL COURT-MARTIAL CONVENING AUTHORITY: You may:
 - a. Retain the respondent in the Air Force.
 - b. Direct the case be reinitiated under another paragraph, if you deem it appropriate.
- *c*. Recommend the respondent be separated with an honorable discharge, with or without probation and rehabilitation, and forward the case to the General Court-Martial Convening Authority (1 1 AF/CC) or his designee (1 1 AF/CV) for action.
- **d.** Direct that the respondent be separated with a general discharge, with or without probation and rehabilitation.
- 6. <u>RECOMMENDATION</u>: I have reviewed this discharge package and find it legally sufficient to support involuntarily discharging a misconduct is in complete contrast with Air Force Standards and totally outside the realm of acceptable behavior. He has continually reported late for duty and shown total disregard for standard operating procedures. After he was given multiple opportunities for improvement has still not shown any changes in his attitude or behavior. It is apparent that one with the standard of behavior exhibited by the standard of behavior. Therefore, I recommend

he be separated with a general discharge, without the opportunity for probation and rehabilitation.

SUBJECT: Notification Memorandum

- **1.** I am recommending your discharge from the United States Air Force for Misconduct Minor Disciplinary Infractions. The authority for this action is AFPD **36-32** and **AFI 36-3208**, paragraph **5.49**. If my recommendation is approved, you will be discharged and your service will be characterized **as** general. You will not be given an opportunity for probation and rehabilitation.
- 2. My reasons for this action are as follows:
- a. On or about **16** Mar **99**, you were late for duty. For this infraction, you received a Letter **of** Counseling, dated **16** Mar **99** (Atch 1).
- b. On or about **30 Mar 99**, you were late for duty. For this infraction, you received a Letter of Counseling, dated **30** Mar **99** (Atch 2).
- c. On or about 13 and 14 May 99, you were derelict in the performance of your duty by not taking out the trash as assigned to do so. For this infraction, you received a Letter of Counseling on 14 May 99 (Atch 3).
- d. On or about 2 Sep 99, you were late for duty. For this infraction, you received a Letter of Counseling, dated 2 Sep 99 (Atch 4).
- e. On or about 1 Oct **99**, you were late for duty. For this inhetion, you received a Letter **of** Counseling, dated 1 Oct **99** (Atch 5).
- f. Between on or about 26 Aug 99 and 1 Oct 99, you were derelict in the performance of your duty by negligently-failing to complete the Technical Order annual A page check by the prescribed date. Between on or about 27 Sep 99 and 1 Oct 99, you were derelict in the performance of your duty by failing to sign the vehicle AF Form 1800, not locking the vehicle after being told to do so while not driving it, arriving for work 50 minutes late, leaving for TDY without processing out of the squadron Orderly Room, and not informing your work center of your TDY billeting room telephone number. For these infractions, you received a Letter of Reprimand, dated 25 Oct 99 (Atch 6).
- g. On or about 4 Nov 99, you were counseled on your responsibilities in the work center. For this, you received a Letter of Counseling, dated 4 Nov 99 (Atch 7).
- h. On or about 12 Nov 99, you left your appointed place of duty without authority. For this infraction, you received an Article 15, dated 22 Nov 99 (Atch 8).

- i, On or about 11 Jan 00, you dishonorably failed to maintain sufficient funds in your bank account to cover checks you wrote. For this infraction you received an Article 15, dated 17 Apr 00 (Atch 9).
- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or higher authority will decide whether you will be discharged or retained in the Air Force and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force and any special pay, bonus, or education assistance funds may be subject to recomment.
- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult Area Defense Counsel, Building 3112, Room 155, Eielson AFB, Alaska, on /6/May00at 0830 hrs. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by (3 duty days) 18 May 00, 1500, will less you request and receive an extension for good cause shown. I will send **then** to the separation authority.
- 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 7. You have been scheduled for a medical examination. You must report to the Physical Examination Section, 354th Medical Group, Building 3349, at 1530 on 15 May 00 for the examination.
- **8.** Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. **A** copy of AFI 36-3208 is available for your use in your orderly room.
