AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD2000-0283

GENERAL: The applicant appeals for upgrade of discharge to Honorable.

The applicant appeared and testified before the Discharge Review Board (Board) without counsel at Dobbins AFB, GA on November 21, 2002.

The following additional exhibits were submitted at the hearing:

FINDINGS: Upgrade of discharge is denied.

The Board finds that neither evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

ISSUES: The applicant's issues are listed in the attached brief. He contends his discharge was too harsh because he was immature and the offenses were of an isolated and minor nature, and he performed his duties well. He further contends that his First Sergeant had a vendetta against the applicant's brother and punished the applicant. He states that he has been a good citizen since his discharge. The applicant was discharged with an under honorable conditions (general) discharge for Misconduct, Discreditable Involvement with Military or Civil Authorities after 1 year, 1 month and 3 days of service. The member received 3 Records of Counseling, 3 Letters of Reprimand, and 2 Article 15's for being drunk and disorderly, wrongful consumption of alcohol underage, wrongful use with intent to deceive another's military identification card, failure to appear in civilian court, failure to go, driving illegally, and failed room inspection. The DRB concluded that the applicant had ample opportunities to correct his recurring pattern of misconduct that was a significant departure from conduct expected of all military members. The Board did not agree that the applicant's misconduct was minor or isolated. There was no evidence to suggest that the applicant's supervisor improperly targeted him because of the applicant's brother. The DRB was impressed with the applicant's post service accomplishments and work in the defense related aerospace industry directly supporting the Air Force. However, no inequity or impropriety in his discharge was found in the course of the hearing. The Board concluded the misconduct of the applicant was appropriately characterized.


CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.



- 1. This discharge action was initiated under AFR 39-10, Chapter 5, paragraph 5-47a, a pattern of misconduct consisting of discreditable involvement with military or civil authorities. The squadron commander recommends a general discharge without probation and rehabilitation. The recommendation for this discharge is based upon the information contained in paragraph 2 of the Letter of Notification, summarized as follows:
- a. On 12 August 1990, then was apprehended for underage possession of an alcoholic beverage, disorderly conduct and drunkenness at the Rockwave Nightclub for which he received nonjudicial punishment under Article 15 consisting of a reduction to the grade of Airman Basic.
- b. On 19 July 1990, then was apprehended for underage possession of an alcoholic beverage for which he received a Letter of Reprimand.
- c. On 1 June 1990, then failed a room inspection for which he was counseled.
- d. On 17 April 1990, then Associated failed to appear in civilian court for failing to wear a seatbelt and speeding. The civilian court issued a warrant for his arrest. As a result he received a Letter of Reprimand and an entry into his Unfavorable Information File.
- e. On 13 April 1990, then April 1990 failed to report for duty for which he received a Letter of Reprimand.
- f. On 31 March 1990, then was apprehended for underage possession of an alcoholic beverage and misuse of a military identification card for which he received nonjudicial punishment under Article 15 consisting of thirty days correctional custody.
- g. On 16 March 1990, then failed to report for duty at the designated time for which he received a record of individual counseling.
- h. On 3 March 1990, then control operated his motorcycle on Randolph Air Force Base without completing the required motorcycle safety course for which he was counseled.

- 2. The respondent is 20 years of age and is not married. He enlisted on active duty on 15 August 1989 and this is his first duty assignment. The respondent has no EPRs. After consulting with the Area Defense Counsel, the respondent has waived his right to submit statements.
- 3. As discharge authority, you may:
 - a. Direct Retention; or
- b. Direct separation with a general discharge either with or without probation and rehabilitation; or
- c. Forward the case to AFMTC/CC with a recommendation that the respondent be separated with an honorable discharge, with or without probation and rehabilitation.
- 4. I recommend that you direct separation with a general discharge without probation and rehabilitation. A preponderance of the evidence in the file supports this recommendation. The respondent simply refuses to conform to the standards of bearing and behavior expected of an airman. The respondent's record does not merit an honorable discharge and his continuing pattern of behavior after rehabilitative measures weighs against offering probation and rehabilitation.



- 1. I am recommending your discharge from the United States Air Force for a pattern of misconduct consisting of discreditable involvement with military or civilian authorities. The authority for this action is AFR 39-10, paragraph 5-47a. If my recommendation is approved, your service will be characterized as honorable or general. I recommending that your service be characterized as general.
- 2. My reasons for this action are:
- a. On 12 August 1990 you were apprehended for underage possession of an alcoholic beverage, disorderly conduct and drunkeness at the Rockwave Nightclub for which you received nonjudicial punishment under Article 15, UCMJ, consisting of reduction to the grade of airman basic. (Atch 1a)
- b. On 19 July 1990 you were apprehended for underage possession of an alcoholic beverage for which you received a Letter of Reprimand dated 20 August 1990. (Atch 1b)
- c. On 1 June 1990 you failed a room inspection for which you received a Record of Individual Counseling dated 5 June 1990. (Atch 1c)
- d. On 17 April 1990 you failed to appear in civil court and a warrant was issued for your arrest for failing to wear your seat belts and speeding for which you received a Letter of Reprimand dated 23 April 1990 and an entry was made in your UIF. (Atch 1d)
- e. On 13 April 1990 you failed to report for duty for which your received a Letter of Reprimand dated 16 April 1990. (Atch 1e)
- f. On 31 March 1990 you were apprehended for underage possession of an alcoholic beverage and misuse of a military identification card for which you received nonjudicial punishment under Article 15, UCMJ, consisting of thirty days correctional custody. (Atch 1f)

- On 16 March 1990 you failed to report for duty at the designated time for which you received a Record of Individual Counseling dated 16 March 1990. (Atch lg)
- On 3 March 1990 you operated your motorcycle on base without having completed the MOST Course II for which you received a Record of Individual Counseling dated 5 March 1990. You were then given a direct order in writing not to operate your motorcycle on base until you had completed the MOST Course II. (Atch 1h)

- If you fail to consult counsel or to submit statements in you own behalf, your failure will constitute a waiver of your right to do so.
- You have been scheduled for a medical examination. You must report to 12 FTW Clinic at 0730 hours and 1345 hours on 7 Sep 90 for the examination.
- Any personal information you furnish in rebuttal is covered by the Privacy Act Statement as explained in AFR 39-10, attachment 6. A copy of AFR 39-10 is available for you use in the orderly room.
