GENERAL: The applicant appeals for upgrade of discharge to Honorable, to change the Reason and Authority for discharge, and to change the RE Code.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains the available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.
The board finds that neither evidence of record nor that provided by the applicant substantiates an inequity or impropricty, which would justify a change of discharge.

ISSUE: The applicant does not contest the discharge; he wants his discharge upgraded so he can reenter the Air Forcc. He states that he now has a wile and a baby and the military would be the best thing for him because he is having a hard time paying the bills and there is not much work in the area that he resides in. The Board reviewed the entire record and found no evidence of impropriety or inequity in this case on which to base an upgrade of discharge. The records indicated the applicant received five Letters' of Reprimand for failure to go, disobeying a lawful order, and being belligerent and verbally abusive to a customer service representative at a local bank. He also received three AETC Form 341's and three AETC 173 'sfor failure to go, dereliction of duty, failure to shave, insubordination, failing uniform inspection and failure to follow instructions and being disruptive to the class. The Board found no cvidence of impropriety or inequity in this case on which to base an upgrade of discharge. The Board concluded the misconduct of the applicant appropriately characterized his term of service.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the board further concludes that there cxists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

## SUBJECT: Legal Review, Recommendation for Discharge 366 TRS, Det 7

1. We have reviewed this discharge case file and find it to be legally sufficient to support discharge in accordance with the provisions of AFI 36-3208. Based upon our review, we conclude that the incidents documented within this file sufficiently supportwnemern discharge from the Air Force. We concur with the 366 TRS, Deft 7/CC that discharged for his misconduct and that his service should be characterized as an under honorable conditions (general) discharge in accordance with AFJ 36-3208, paragraph 5.49 (minor disciplinary infractions).
2. On 14 Oct 99 , the 366 TRS, Net $7 / \mathrm{CC}$ notified be discharged from the service due to his misconduct. The basis for this action is the detachment commander's administrative determination that the respondent has committed a series of minor disciplinary infractions. Specifically, while stationed at Fort Leonard Wood MO, the respondent failed to go at the time prescribed to his appointed place of duty, to wit: details, and on three occasions, to Physical Conditioning. In addition, performance of his duties when he slept in class. Further, he disobeyed a lawful order; he failed to shave; he failed a uniform inspection; he was insubordinate when he demonstrated disregard for directions and displayed an attitude of indifference; and he failed to follow instructions and was disruptive in class. Finally brought discredit upon himself and the United States Air Force when he became belligerent and verbally abusive to an employee of a local bank. The respondent received five Letters of Reprimand, three AETC Forms 173, and three AETC Forms 341 as the result of his misconduct. The basis for discharge is supported by a preponderance of evidence in the case file.
3. The respondent is 19 years old. He began his present enlistment on 24 Mar 99, and was assigned to his unit on 17 May 99. His ASVAB scores are below average. The respondent is entitled to wear the Air Force Training Ribbon. He has consulted counsel and has waived his right to submit statements for your consideration.
4. In accordance with AFI 36-3208, your options are to:

b. Direct his discharge with an under honorable conditions (general) discharge; or
c. Recommend that discharged with an honorable discharge. If you determine an honorable discharge is appropriate, this file must be forwarded to $2 \mathrm{AF} / \mathrm{CC}$ since only a General Court-Martial Convening Authority may approve an honorable discharge characterization when the basis for discharge is misconduct (AFI 36-3208, paragraph 5.48.4).

If my recommendation is approved, your service will be characterized as honorable or under honorable conditions (general). I am recommending that your service be characterized as under honorable conditions (general).

e. You did at or near Fort Leonard Wood MO, on or about 17 Sep 90 , without authority, fail to go at the time prescribed to your appointed place of duty, to wit: Physical Conditioning. For this misconduct you received an LOR on 17 Sep 99.
d. You were, at or near hort Leonard Wood MO, on or about 27 Aug 99, without authority, Gail to go at the prescribed time to your appointed place of duty, wo wit: Physical Conditioning. Jor this misconduct, you received an AFTC Form 341. Discrepancy Report, on 27 Aug 99.
e. You were, at or near Fort I, eonarg Wood MO, on or about 19 Aug 99, willfully disobey a lawful order, by not waiting for as instructed. lion this misenduct you received in LOR on 19 Aug 99 .
f. You who knew or should have known of your duties at Fort leonard Wood MO, on or about 3 Aug 99 , were derelict in the performance of those duties by sleeping in class, as it was your duty not to do. For this misconduct you received an AETC Form 173, Student Record of Academic/Non-Academic Counseling and Comments, on 3 Aug 99.
b. You did, al or near Fort Lenard Wood MO, on or about 9 fol 99 . fail to shave. For this misconduct you received an AFTC Form 341, Discrepancy Report, on 9 , Jul 99.
h. You were, at or near Fort l, eonerd Wood MO , on or about 6 Jul 99 , bring discredit upon yourself and the United States Air Force by becoming belligerent and verbally abusive to a customer service representative ut a local bank. For this infraction. you received an LOR on 7 Jul 99.
i. You did, al or near Fort Lenard Wood MO, on or about 30 Jun 99, insubordinate. Specifically, you have demonstrated disregard for directions and an attitude of indifference. For which you received an ABIC Form 173 on 30 Jun 99.
j. You did, at or near Fort Leonard Wood MO, on or about 29 Jun 99 , fail a uniform inspection. lion this misconduct you received an ABIC For 341, Discrepancy Report, on $29 \operatorname{Jan} 99$.
k. You did, at or near Font Leonard Wood MO, on or about 4 Jun 99, fail to follow instruction and were disruptive to the class. For this misconduct you received an AFt Form 173 on 4 Jun 99.
3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force and, if your are discharged, how your service will be characterized. If you are discharged, you will be ineligible fir reenlistment in the Air Force, and will probably be dented enlistment in any component of the Armed Forces.
4. You have the right to consult counsel. Military legal counsel has been obtained to assist you.

5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by 190 Ot 99 unless you request and receive an extension for good cause shown. I will send them to the separation authority.
6. If you fail to consult counsel or submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
7. You have been scheduled for a medical examination. You must report to the Consolidated Troop Medical Clinic at 0800 on 150 cl 99 for the examination.
8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. $\Lambda$ copy of AFI 36-3208 is available for your use in the orderly room.
