AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD2002-0244

GENERAL: The applicant appeals for clemency in the form of an upgrade of his discharge to General (under honorable conditions).

The applicant appeared and testified before the Discharge Review Board (DRB or Board), with counsel, at Andrews AFB, MD, on January 23, 2003.

The attached brief contains the available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: The discharge is upgraded to General (under honorable conditions).

ISSUE: The applicant contends his discharge was inequitable because it was too harsh. The records indicated the applicant received a Bad Conduct Discharge (BCD) pursuant to his conviction for AWOL and Failure to Go. The applicant's defense counsel, after discussing the matter with the applicant and after the applicant discussed the matter on the record with the military judge, argued for a BCD in lieu of confinement. The applicant was sentenced to the BCD and reduction to the lowest enlisted grade. After a thorough and complete consideration of the information submitted by the applicant, the applicant's compelling personal testimony, and information contained in the record, the Board concluded that the BCD was simply too harsh a punishment for the offense of which the applicant had been convicted. While it is appropriate for the applicant to have the federal conviction, the Board did not think the crimes so serious as to justify a BCD. Therefore, clemency is appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the Uniform Code of Military Justice and the Manual for Courts-Martial, was within the discretion of the military judge and convening authority, and that the applicant was provided full procedural and substantive due process.

However, in view of the foregoing findings, the Board further concludes that the overall quality of applicant's service, when compared to the crimes of which he was convicted, is more accurately reflected by a General discharge. The applicant's characterization should be changed to General (under honorable conditions).
