AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD2002-0291

GENERAL: The applicant appeals for upgrade of discharge to general.

The applicant appeared and testified before the Discharge Review Board (DRB), without counsel, at the American Red Cross, Albany NY, on 24 October 2003. The following additional exhibits were submitted at the hearing:

Exhibit 6: Character Reference, 20 August 1991.

Exhibit 7: Character Reference, 5 September 1991,

Exhibit 8: Character Reference, 9 December 1991

Exhibit 9: Character Reference, 11 April 2003,

Exhibit 10: Character Reference, Undated,

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: The Board grants the requested relief.

The Board finds that the evidence of record and that provided by the applicant provides a sufficient basis in clemency for a change of discharge.

ISSUE:

The DRB was pleased to see that the applicant was doing well, has two good jobs and is a supportive husband and father. The applicant has claimed that he has refrained from drug use and is now a good citizen.

The applicant did not receive an administrative discharge, thus his contention of inequity is not applicable. The applicant received a Bad Conduct Discharge, a punitive discharge, as part of his sentence resulting from a Special Court-Martial conviction. Under the provisions of Section 1553, 10 USC, the only basis for a change of a Bad Conduct discharge is clemency. The applicant presented evidence that the DRB opined did warrant granting clemency.

CONCLUSIONS:

The Discharge Review Board concluded that the applicant's punitive discharge by Special Court-Martial is not appropriate under the facts and circumstances of this case and there is sufficient basis, as an act of clemency, for change of discharge. The applicant's discharge is more appropriately characterized as general.
