#### AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD2002-0481

**GENERAL:** The applicant appeals for upgrade of discharge to honorable, and to change the reason and authority for his discharge, and to change his reenlistment code.

The applicant was offered a personal appearance before the Discharge Review Board but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

**FINDINGS**: Upgrade of discharge, change of reason and authority for the discharge, and reenlistment code are denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an impropriety or inequity that would justify an upgrade of the discharge to honorable.

Issues. Applicant was discharged for misconduct, conduct prejudicial to good order and discipline. He had three Letters of Reprimand, a Record of Individual Counseling, and two Articles 15. His misconduct included two instances of financial irresponsibility, two incidents of making false official statements, failure to go, and theft. Additionally, the record review revealed that member appeared to have been on the Weight Management Program. The Board noted that when his misconduct occurred, member was age 36 to 37 and was a noncommissioned officer who had between 17 and 19 years of service. He knew right from wrong, so he was held accountable for his actions. At the time of the discharge, member submitted a conditional waiver of his right to an administrative board hearing based on receipt of an under honorable conditions (general) discharge, which was granted. In a reply to the discharge, he also requested to be separated at the earliest opportunity noting he was no longer a good fit for the Air Force and wanted to get on with his life. He conceded he was giving up many years of service, medical benefits, retirement benefits, and the right to lengthy service probation consideration. Member now notes he was on a remote assignment in Korea and was undergoing a divorce that clouded his judgment. The Board recognized that applicant's marital problems may have had some bearing on his difficulties but found them insufficient mitigation for his misconduct. While it is understandable that a member experiencing personal problems has additional stress, applicant's problems were not unique. There was no evidence he sought assistance from available base agencies such as the Chaplain, Family Support Center, Mental Health Clinic, or his chain of command. Because he was unable to separate his personal problems from his duties, he became an administrative burden to the unit, and was unable or unwilling to adjust his behavior. Although given many opportunities, he failed to correct his negative behavior. The record review offered no basis to substantiate an upgrade or to change his reenlistment code. The Board could find no wrongful action by the Air Force, nor an inequity or impropriety.

The applicant cited his desire to return to military service. While the Board commends applicant on this desire, and is sympathetic to the impact a General discharge has on his reenlistment code, this is not a matter of equity or propriety that warrants an upgrade.

**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was essentially consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

- 1. I am recommending your discharge from the United States Air Force for a pattern of misconduct (conduct prejudicial to good order and discipline). The authority for this action is AFPD 36-32 and AFI 36-3208, section 5.50.2. Copies of the documents to be forwarded to the separation authority to support this recommendation are attached.
- 2. My reasons for this action are as follows:
- a. On or about 21 Jan 99, you failed to pay a just debt to American Express. For this offense, you received a Letter of Reprimand (LOR), dated 1 Mar 99 (Atch 1a).
- b. On or about 5 Aug 99, you did, with the intent to deceive, make a false official statement to For this offense, you received an LOR, dated 12 Aug 99 (Atch 1b).
- c. You, did, at or near Moody Air Force Base, Georgia, on or about 17 February 2000, with the intent to deceive, make to spoke to
- d. On or about 30 Mar 00, you issued a check to Western Auto in the amount of \$21.39. Subsequently, you failed to maintain sufficient funds in your account to pay the check, thus Lowndes County Sheriffs served you with an arrest warrant for deposit fraud. For this offense, you received an LOR, dated 9 Jun 00, which was placed in a Unfavorable Information File (Atch 1e).
- e. On or about 28 Apr 00, you failed to go to your appointed place of duty. For this incident, you received a Letter of Counseling, dated 4 Jan 00 (Atch 1e).
- f. You, did, at or near Moody Air Force Base, Georgia, on or about 7 June 2000, steal one can of Skoal chewing tobacco, of a value of about \$2.40, the property of the Moody Air Force Base Shoppette. For this offense, you received nonjudicial punishment pursuant to Article 15, UCMJ. Punishment included reduction to the grade of senior airman (Atch 1f).

3. This action could result in your separation with an under other than honorable conditions discharge. I am recommending that you receive an under honorable conditions (general) discharge. If you are discharged, you will be ineligible for reenlistment in the Air Force.

- 4. You have the right to:
  - a. Consult legal counsel;
  - b. Present your case to an administrative discharge board;
  - c. Be represented by legal counsel at a board hearing;
- d. Submit statements in your own behalf in addition to, or in lieu of, the board hearing; and,
- e. Waive the above rights. You must consult legal counsel before making a decision to waive any of your rights.
- 5. You have been scheduled for a medical examination. You must report to the Moody Air Force Base Hospital, Physical Exams Section, Bldg 3296, at <u>1300</u> on <u>6 July 00</u> for the examination. This is a mandatory appointment.
- 6. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to contact in Bldg 5109, Room 3, extension 3421, on 6 July 00 at 0900. Please take your copy of this Notification Memorandum and attachments with you to your appointment. Instead of the appointed counsel, you may have another, if the lawyer you request is in the active military service and is reasonably available as determined according to AFI 51-201. In addition to military counsel, you have the right to employ civilian counsel. The Air Force does not pay expenses incident to the employment of civilian counsel. Civilian counsel, if employed, must be readily available.
- 7. Confer with your counsel and reply, in writing, within seven (7) workdays, specifying the rights you choose to exercise. The statement must be signed in the presence of your counsel who also will sign it. If you waive your right to a hearing before an administrative discharge board, you may submit written statements in your own behalf. I will send the statements to the discharge authority with the case file to be considered with this recommendation. If you fail to respond, your failure will constitute a waiver of the right to the board hearing.
- 8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in the orderly room.
- 9. If you request a board and you fail to appear without good cause, your failure to appear constitutes a waiver of your right to be present at the hearing.
- 10. The discharge board or, the discharge authority will make the finding and recommendations required under 10 U.S.C. 2005(g).
