AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD03-0041

GENERAL: The applicant appeals for upgrade of discharge to Honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains the available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The board finds that the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was able to identify none that would justify a change of discharge.

ISSUE: The applicant submitted no issues and requested that the review be completed based on the available service record. The Board reviewed the entire record and found no evidence of impropriety or inequity in this case on which to base an upgrade of discharge. The records indicated applicant had received two Article 15's for, with intent to deceive, make an official statement that was false. And, for being derelict in the performance of his duties by downloading games on his government computer. In addition, he also received three Letters of Reprimand for failure to obey a lawful order, failure to follow established procedures and not being truthful when questioned about it, and for substandard performance, behavior, adaptability and habitual lying. In addition, he received four Letters of Counseling for violation of uniform policies, making a false official statement, being late for work and violation of safety standards. The Board concluded the disciplinary infractions were a significant departure from the conduct expected of all military members. The Board found no evidence of impropriety or inequity in this case on which to base an upgrade of discharge.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

SUBJECT: Notification Memorandum

1. I am recommending your discharge from the United States Air Force for a Pattern of Misconduct, Conduct Prejudicial to Good Order and Discipline. The authority for this action is AFPD 36-32 and AFI 36-3208, paragraph 5.50.2. If my recommendation for discharge is approved, your service will be characterized as either honorable or under honorable conditions (general). I am recommending that your service be characterized as under honorable conditions (general).

2. My reasons for this action are:

- a. Between on or about 29 March 2002 and on or about 12 April 2002, you failed to refrain from downloading games on your government computer. For your actions, you received nonjudicial punishment under Article 15, UCMJ (Atch 1-1).
- b. On or about 18 December 2001, you failed to follow the orders of your section commander. For your actions, you received a letter of reprimand (LOR) (Atch 1-2).
- c. On or about 4 December 2001, you failed to properly inventory your tool box according to prescribed rules. For your actions, you received an LOR (Atch 1-3).
- d. On or about 3 December 2001, you were out of uniform standards. For your actions, you received a letter of counseling (LOC) (Atch 1-4).
- e. On or about 27 November 2001, you failed to wear your air-supplied full faced respirator while inside the fuel tank as specified by regulation. For your actions, you received an LOC (Atch 1-5).
- f. On or about 21 July 2000, you made a false official statement to two NCOs regarding the clinic placing you on quarters. For your actions, you received nonjudicial punishment under . Article 15, UCMJ (Atch 1-6).

- g. On or about 6 June 2000, you made a false official statement to another airman concerning the whereabouts of your line area badge. For your actions, you received an LOC (Atch 1-7).
- h. On or about 22 May 2000, you failed to go at the time prescribed to your appointed place of duty. For your actions, you received an LOC (Atch 1-8).
- i. On or about 18 February 2000 and on or about 22 February 2000, you failed to go at the time prescribed to your appointed place of duty. For your actions, you received an LOR (Atch 1-9).
- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or higher authority will decide whether you will be discharged or retained in the Air Force and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force.
- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult Area Defense Counsel, Bldg 1255, Rm 201, Telephone 7-3260 on 11 June 2002 at 1400 hours. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me within (3) workdays unless you request and receive an extension for good cause shown. I will forward any statements you submit to the separation authority.
- 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 7. You have been scheduled for a medical examination. You must report to Little Rock AFB Clinic at 1500 hours on 13 June 2002 for the examination.
- 8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in the Orderly Room.
- 9. Execute the attached acknowledgment and return it to me immediately.
