AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2003-00175

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of Discharge is denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

ISSUE:


The applicant contends that he should not be penalized indefinitely for mistakes he made when young. The DRB recognized the applicant was 20 years of age when the discharge took place. The records indicate applicant received three Article 15s, four Letters of Reprimand, three Letters of Counseling, and two Records of Individual Counseling. His misconduct included loitering on post, failure to go on numerous occasions, missed appointments, late for work and failure to follow orders, failed dorm inspections, dereliction of duty, assault, driving while disqualified, speeding, and a civil arrest. There is no evidence he was immature or did not know right from wrong. The Board opined the applicant was older than the vast majority of first-term members who properly adhere to the Air Force's standards of conduct. The DRB was pleased to see that the applicant was doing well and has a good job. However, no inequity or impropriety in his discharge was suggested or found in the course of the hearing. The Board concluded the misconduct of the applicant appropriately characterized his term of service.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

- 1. I am recommending your discharge from the United States Air Force for a Pattern of Misconduct. The authority for this action is AFPD 36-32 and AFI 36-3208, paragraph 5.50. If my recommendation is approved, your service will be characterized as either honorable or general, under honorable conditions. I am recommending that your service be characterized as general, under honorable conditions.
- 2. My reasons for this action is based on the following information:
 - a. On or about 1 July 1999 and 22 July 1999, you reported late for duty. For this misconduct, you received a Letter of Reprimand, dated 22 July 1999 (Attachment 1).
 - b. On or about 28 January 2000, you failed to go to your reported place of duty and made a statement with intent to deceive. For this misconduct, you were punished under Article 15, UCMJ, dated 10 February 2000 (Attachment 2) and an Unfavorable Information File was established.
 - c. On or about 4 March 2000 and 10 March 2000, you failed to go to your appointed place of duty. For this misconduct, your suspended punishment under Article 15, UCMJ, dated 10 February 2000, was vacated on 24 April 2000 (Attachment 3).
 - d. On or about 8 May 2000, you reported late for duty. For this misconduct, you received a Letter of Reprimand, dated 8 May 2000 (Attachment 4).
 - e. On 28 February 2001, you were driving while disqualified. For this misconduct, you received a Letter of Reprimand, dated 9 March 2001 (Attachment 5).
 - f. On or about 5 April 2001, you, while posted as a sentinel, loiter while on post. For this misconduct, you received an Article 15, UCMJ, dated 20 April 2001 (Attachment 6).
 - g. On or about 7 February 2001, you participated in an assault off base on Sidney St., Cambridge, Cambridgeshire, United Kingdom. For this misconduct, you received a Letter of Reprimand dated 24 April 2001 (Attachment 7).
- 3. Other derogatory Information

On or about 18 October 1999, you failed to go to a mandatory fitness test. For this misconduct, you received a Letter of Counseling, dated 20 October 1999 (Attachment 8).

From on or about 10 January 2000 to 16 February 2000, you failed to complete volume 1 of your Career Development Course by the completion date. For this misconduct, you received a Record of Individual Counseling, dated 22 February 2000 (Attachment 9).

On or about 4 March 2000, you reported late for duty. For this you received a Letter of Counseling, dated 4 March 2000 (Attachment 10).

On or about 10 March 2000, you failed to attend a scheduled Commander's Call. For this, you received a Letter of Counseling dated 13 March 2000 (Attachment 11).

On or about 22 June 2000, you failed to meet the minimum standards for your dormitory inspection. For this misconduct, you received a Record of Individual Counseling (Attachment 12).

- 4. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force.
- 5. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult Capt the Area Defense Counsel, RAF Lakenheath, Suffolk, DSN: 226-3608, at 0900 hours, on 8 May 2001. You may consult civilian counsel at your own expense.
- 6. You have the right to submit matters on your own behalf. Any statements you want the separation authority to consider must reach me byl²⁰⁰ on 10 May 2001, unless you receive an extension for good cause shown. I will send whatever you submit to the separation authority.
- 7. If you fail to consult counsel or to submit statements in you own behalf, your failure will constitute a waiver of your right to do so.
- 8. You have been scheduled for a medical examination. You must report to RAF Upwood, Primary Care Section, on 7 May 2001, at 1430 hours for the examination.
- 9. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208, is available for your use in the 423 ABS Orderly Room.
