1. **MATTER UNDER REVIEW:** Appl rec'd a UOTH Disch fr USAF 10 Oct 02 UP AFI 36-3208, para 5.52.3 (Misconduct - Commission of a Serious Offense). Appeals for General Discharge.

2. **BACKGROUND:**

b. Prior Sv: (1) AFRes 23 Mar 99 - 3 Aug 99 (4 months 12 days) (Inactive).

3. **SERVICE UNDER REVIEW:**

a. Enlisted as AB 4 Aug 99 for 6 yrs. Svd: 3 Yrs 2 Mo 7 Das, of which AMS is 3 yrs 2 months 1 day (excludes 6 days lost time).

b. Grade Status: SrA - 24 Jan 02
A1C - 17 Sep 99

c. Time Lost: 30 May 02 thru 5 Jun 02 (6 days).

5. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult with an attorney at the Area Defense Counsel's Office at Building 292, extension 3248, on 21 Jun 02 at 1030. Instead of the appointed counsel, you may have another, if the lawyer you request is in the active military service and is reasonably available as determined according to AFI 51-201. In addition to military counsel, you have the right to employ civilian counsel. The Air Force does not pay expenses incident to the employment of civilian counsel. Civilian counsel, if employed, must be readily available.


6. Confer with your counsel and reply, in writing, within seven workdays, specifying the rights you choose to exercise. The statement must be signed in the presence of your counsel who also will sign it. If you waive your right to a hearing before an administrative discharge board, you may submit written statements in your own behalf. I will send the statements to the discharge authority with the case file to be considered with this recommendation. If you fail to respond, your failure will constitute a waiver of the right to the board hearing.

7. You must report to Physical Exams at 0730 hours, on the next duty day after being served, for an examination.

8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in your Command Support Staff office.

9. If you request a board and you fail to appear without good cause, your failure to appear constitutes a waiver of your right to be present at the hearing.

10. Execute the attached acknowledgment and return it to me immediately.
