AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any.

Issues. Applicant was discharged for minor disciplinary infractions and a mental health disorder. He had two Articles 15, a vacation of suspended punishment, four Letters of Reprimand, and two Records of individual counseling. His misconduct included twice failure to go, failure to follow instructions, a dress and appearance violation, financial irresponsibility, and three instances of disobeying a lawful order not to drive his privately owned vehicle on base. Member's one Enlisted Performance Report was rated an overall "3" and noted he needed to be more receptive to his supervisor's comments and advice to be more productive. Member was also permanently decertified from the Personnel Reliability Program for failure to pay debts to six different loan institutions. Additionally, member was diagnosed with an anti-social personality disorder at that time. The copy of member's discharge file available to the Board for review was incomplete, therefore the Board was unable to ascertain further details about member's misconduct or mental health diagnosis. The Board also could not determine if member consulted counsel, although they noted he waived his right to submit statements on his own behalf at the time of the discharge. Lacking evidence from the applicant to the contrary, the Board relies on the presumption of regularity and finds the discharge proper and without basis for an upgrade. No inequity or impropriety could be found in this discharge in the course of the records review.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

The authority for this action is AFPD 36-32 and AFI 36-3208, para 5.49 and 5.11.1. If my recommendation is approved, your service may be characterized as UNDER HONORABLE CONDITIONS (GENERAL). I am recommending that your service be characterized as UNDER HONORABLE CONDITIONS (GENERAL) and that Minor Disciplinary Infractions be the primary basis for discharge.

2. My reason(s) for this action is/are as follows:

a. On or about 11 Jul 00, you drove onto Barksdale Air Force knowing that your on-base driving privileges had been suspended, as evidenced by a Vacation Action dated 21 July 00. (atch a);

b. On or about 7 Jul 00, you were diagnosed with an Antisocial Personality Disorder, as evidenced by a PRP Recommendation Letter dated 7 Jul 00. (atch b);

c. On or about 17 May 00, you willfully failed to refrain from driving on base without a valid drivers license, as evidenced by an Article 15 dated 8 Jun 00. (atch c);

d. On or about 18 Apr 00, you failed to go to a mandatory appointment, as evidenced by a Letter of Reprimand (LOR) dated 27 Apr 00 (atch d);

e. On or about 20 Apr 00, you failed to attend a mandatory commanders call, as evidenced by an LOR dated 27 Apr 00 (atch d);


f. On or about 21 Apr 00, you failed to pay your debt to American Cash Advance, as evidenced by an LOR dated 27 Apr 00 (atch d);

g. On or about 21 Apr 00, you were counseled regarding your failure to maintain military dress and appearance standards, as evidenced by a Record of Individual Counseling (RIC) dated 25 Feb 00 (atch e);

h. On or about 4 Oct 99, you willfully failed to follow instructions regarding the proper wear of your Chemical Warfare Mask, as evidenced by an LOR dated 15 Oct 99 (atch f);

i. On or about 5 Jun 99, you were given a traffic ticket from 2d security Forces for exceeding the posted speed limit, as evidenced by a RIC dated 10 Jun 99. (atch g);

3. Copies of the document(s) referenced above have been attached and will be forwarded to the separation authority in support of this recommendation. The commander exercising SPCM jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force, and if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for re-enlistment in the Air Force.

4. Military legal counsel, Capt Area Defense Counsel for Barksdale AFB, Extension 6-8355, Building 4714 (gym annex building), third floor, has been obtained to assist you. An appointment has been scheduled for you to consult with him on 20 Jyp at 0902 hrs. You may consult civilian counsel at your own expense.

5. You have been scheduled for a medical examination. You must report to Flight Medicine with your medical records for the appointment. Your appointment is on $\frac{24}{1230}$ at $\frac{1230}{1230}$ hours.

6. You have the right to submit statements in your behalf. Any statements you want the separation authority to consider must reach me within three (3) duty days unless you request and receive an extension for good cause. I will send any statements that you provide to the separation authority.

7. You have been scheduled for a Pre-separation Counseling briefing. You must report to the Family Support Center, Bldg 4713, at 0800 on 27 July for the briefing.

8. If you fail to consult counsel or fail to submit statements in your behalf, you will waive the right to do so.

9. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208, the AFI governing this action, is available for your use in your unit Orderly room.
