AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2003-00349

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of Discharge is denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

ISSUE: Applicant contends discharge was inequitable because it was too harsh. The records indicated the applicant received two Article 15s, both for failure to go. He also received one Letter of Reprimand and one Letter of Admonishment and eight Records of Individual Counseling for dereliction of duty, being late for work, financial irresponsibility, sleeping on duty and being disrespectful to an NCO. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.



Issue 1: I believe my discharge was inequitable because it was based solely on my "failure to go"; in essence, I was discharged because I was late to work. I understand that we train ourselves to act and react at all times as though we are at war, and in that scenario my tardiness might have proven fatal to myself or to others. I believe however, that other measures besides discharge should have been taken. My service records will show that no stripes were ever taken; I was never relieved of any rank. In my last EPR I was described as ". . .a poster child for the Air Force" and ". . .an example (uniform and physical fitness) for other airman." Gentlemen, please believe me when I tell you that I loved the military and that an early discharge was the worst thing that anyone could have given to me. I wish to get back into school and finish my degrees in English and Sports Medicine. Of only slightly lesser importance to clearing my name by changing my discharge type to Honorable is the access to the GI Bill, for which I worked over five years to attain. The GI Bill was/is the most important benefit to me and is crucial for me to get through school these next two years. I am currently unable to access this benefit with my General discharge. Please consider my request to change my discharge type to Honorable.

If my recommendation is approved, your service may be characterized as honorable or general. I am recommending that your service be characterized as general.

2. My reasons for this action are:

- a. On or about 13 Mar 99, you were responsible for damaging government property. For your actions, you received a Record of Individual Counseling (ROIC) on 15 Mar 99;
- b. On or about 15 Mar 99, you were late for work. For your actions, you received an (ROIC) on 15 Mar 99;
- c. On or about 16 Mar 99, you were late for work. For your actions, you received an ROIC on 16 Mar 99;
- d. On or about 3 May 99, you were late for work. For your actions, you received an ROIC on 3 May 99;
- e. On or about 6 May 99, you were late for work. For your actions, you received an ROIC on 6 May 99;
- f. On or about 1 Jun 99, your government credit card was 160 days delinquent. For your actions, you received an ROIC on 1 Jun 99;
- g. On or about 14 Jul 99, were late for work. For your actions, you received a Letter of Reprimand (LOR) on 14 Jul 99;
- h. On or about 11 Aug 99, you were found sleeping on duty. For your actions, you received a ROIC on 11 Aug 99;
- i. You did, at or near Nellis Air Force Base, Nevada, on or about 15 Feb 00, without authority, fail to go at the time prescribed to your appointed place of duty, to wit: Rescue



Squadron, Building #61664. For your actions, you were punished under Article 15, Uniform Code of Military Justice (UCMJ) consisting of a suspended reduction to the grade of airman first class and 20 days extra duty on 7 Mar 00;

- j. You did, at or near Nellis Air Force Base, Nevada, on or about 26 Sep 00, without authority, fail to go at the time prescribed to your appointed place of duty, to wit: Building 61664, Inspection Element. For your actions, you were punished under Article 15, UCMJ consisting of a suspended reduction to the grade of airman first class, restriction to the confines of Nellis Air Force Base, Nevada for 45 days, and 45 days extra duty on 12 Oct 00;
- k. On or about 14 May 02, you were late for work. For your actions, you received an ROIC on 16 May 02; and
- 1. On or about 17 May 02, you showed disrespect toward a superior NCO. For your actions, you received a Letter of Admonishment (LOA) on 20 May 02.
- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising special court-martial jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force, and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force.
- 4. You have the right to consult legal counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult the Area Defense Counsel at Building 625 on 13 50 hours. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements in your own behalf. You have three (3) duty days (which includes the date served) to submit statements in your behalf. Any statements you want the separation authority to consider must reach me by 19 June 02 at 0800 hours unless you request and receive an extension for good cause shown. I will send them to the separation authority.
- 6. In the event the commander exercising Special Court-Martial jurisdiction or a higher authority approves your discharge, separations will out-process you. Your initial separations briefing is scheduled for 1800 on 13 3000 or.
- 7. If you fail to consult or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 8. You have previously been scheduled for a medical examination at the 99th Medical Group on 1430 on 13 5 w 02.
- 9. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in your Unit Orderly Room.
