AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2003-00389

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge.


ISSUES: Applicant was discharged for minor disciplinary infractions; he had received two Articles 15, a vacation of suspended punishment, a Letter of Reprimand, a Record of Individual Counseling and three traffic tickets. His misconduct included failure to go on three occasions, and failing to refrain from encouraging the inappropriate handling of a firearm. His traffic violations included twice parking in a fire lane, parking in a no parking zone, and failing to stop at a stop sign, these being in total disregard for the safety of others and resulting in his revocation of base driving privileges. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a departure from conduct expected of all military members. The Board found no evidence of impropriety or inequity in this case on which to base an upgrade of discharge. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.



SUBJECT: Notification Memorandum

- 1. I am recommending your discharge from the United States Air Force for Minor Disciplinary Infractions. The authority for this action is AFPD 36-32 and AFI 36-3208, paragraph 5.49. If my recommendation is approved, your service will be characterized as honorable or general. I am recommending that your service be characterized as general.
- 2. My reasons for these actions are as follows:
- a. On or about 29 May 01, you failed to stop for a posted stop sign. For this infraction, you received a DD Form 1408, dated 29 May 01 (Atch 1) and a verbal counseling.
- b. On or about 6 Dec 01, you were parked in a no parking zone. For this infraction, you received a DD Form 1408, dated 6 Dec 01 (Atch 2).
- c. On or about 28 Dec 01, you were parked in a fire lane. For this infraction, you received a DD Form 1408, dated 28 Dec 01 (Atch 3).
- d. On or about 3 Mar 02, you were parked in a fire lane. For this infraction, you received a DD Form 1408, dated 3 Mar 02, a Record of Individual Counseling, dated 18 Mar 02, and a one month driving suspension (Atch 4).
- e. On or about 17 May 02, you failed to report to your designated duty location at the prescribed time. For this infraction, you received a Letter of Counseling, dated 21 May 02 (Atch 5).
- f. Between on or about 26 Nov and 27 Nov 02, you were absent without authority from your designated duty location. For this infraction, you received nonjudicial punishment, dated 9 Dec 02 (Atch 6) and an Unfavorable Information File was established (Atch 7).
- g. On or about 1 Feb 03, you were derelict in the performance of your duties in that you willfully failed to refrain from encouraging the inappropriate handling of a firearm. For this infraction, your previously suspended punishment was vacated, dated 10 Feb 03 (Atch 8), in addition to receiving nonjudicial punishment, dated 10 Feb 03 (Atch 9) and this discharge action was initiated.

- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or higher authority will decide whether you will be discharged or retained in the Air Force and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force and any special pay, bonus, or education assistance funds may be subject to recoupment.
- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult the Area Defense Counsel's Office, Building 3112, Room 143, Eielson AFB, Alaska, on 12 mar o 3 at 1430 . You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by (3 duty days) 17 mar o 3, unless you request and receive an extension for good cause shown. I will send them to the separation authority.
- 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 7. You have been scheduled for a medical examination. You must report to the Physical Examination Section, 354th Medical Group, Building 3349, 2 1345 for the examination.
- 8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in your orderly room.
