AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD2003-00470

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any.


Issues. Applicant was discharged for conduct prejudicial to good order and discipline. He had two Articles 15, a vacation of suspended punishment, two Letters of Reprimand, and an Unfavorable Information File. His misconduct included three underage drinking incidents, communicating a threat, a computer security violation, being drunk on duty, willfully damaging a government vehicle while repeatedly driving it over a snow bank and doing "donuts," unlawful entry into a dormitory room of another airman, and stealing from that airman. At the time of the discharge, member consulted counsel submitted a statement in his own behalf highlighting the positive aspects of his career. The Board noted member was given many opportunities to correct his behavior but was either unwilling or unable to do so. Because member was responsible for his actions, he was held accountable for them. The Board found nothing during the course of the record review to warrant an upgrade. There was no inequity or impropriety, thus the characterization of service was deemed appropriate in view of the repeated misconduct.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

1. I am recommending your discharge from the United States Air Force for a pattern of misconduct, specifically, conduct prejudicial to good order and discipline. The authority for this action is AFPD 36-32 and AFI 36-3208, paragraph 5.50.2. If my recommendation is approved, your service will be characterized as honorable or under honorable conditions (general). I am recommending that your service be characterized as under honorable conditions (general).


2. My reasons for this action are:

- a. You, who knew of your duties at or near Sheppard Air Force Base, Texas, on or about 23 Feb 02, were derelict in the performance of those duties in that you willfully failed to refrain from consuming alcoholic beverages while under the state legal drinking age of 21, as it was your duty to do. You, did, at or near Sheppard Air Force Base, Texas, on or about 23 Feb 02, wrongfully use a provoking gesture, to wit: your middle finger, towards a Burger King employee. For these actions, you received a Letter of Reprimand (LOR) on 13 Mar 02. This action established your Unfavorable Information File (UIF).
- b. You, who knew of your duties at or near Ellsworth Air Force Base, South Dakota, on or about 1 May 02, were derelict in the performance of those duties in that you willfully failed to refrain from consuming alcoholic beverages while under the state legal drinking age of 21, as it was your duty to do. You were, at or near Ellsworth Air Force Base, South Dakota, on or about 2 May 02, found drunk while on duty as a Mobile Hydrant Operator. For these actions, you received nonjudicial punishment under Article 15, UCMJ, on 4 Jun 02. Punishment consisted of a suspended reduction to the grade of Airman, forfeiture of \$75.00 pay per month for 2 months, restriction to Ellsworth Air Force Base, South Dakota for 15 days, and 15 days extra duty. - e. You, who knew of your duties, at Ellsworth Air Force Base, South Dakota, on 14 Apr 03; were derelict in the performance of those duties in that you willfully failed to refrain from consuming alcoholic beverages while under the state legal drinking age of 21, as it was your duty to do. You, did, at Ellsworth Air Force Base, South Dakota, on 14 Apr 03, steal five cans of beer, of an undetermined value, the property of A1C You, did, at Ellsworth Air Force Base, South Dakota, on 14 Apr 03, unlawfully enter a dormitory room, the property of A1C William with intent to commit a criminal offense, to wit: steal five cans of beer, therein. For these actions, your suspended reduction to the grade of Airman received from the Article 15 imposed on 13 Jan 03 was vacated on 21 May 03.
- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force and, if you are discharged, how your discharge will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force and any special pay, bonus, or education assistance funds may be subject to recoupment.
- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult Captain Area Defense Counsel, 385-2158, 1000 Ellsworth Street, Suite 1700 on 3 fun 03 at 1400 hours. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by $\sqrt{2}$ at $\sqrt{2}$ at $\sqrt{2}$ hours, unless you request and receive an extension for good cause shown, I will send them to the separation authority.
- 6. If you fail to consult counsel or to submit matters in your own behalf, your failure will constitute a waiver of your right to do so.
- 7. You have been scheduled for a medical examination. You must report to Flight Medicine / Family Practice B Section of the Base Clinic on L. June 3 at 1030 hours for the examination. This is a mandatory appointment and you must be in uniform. You must report at least 20 minutes in advance to this appointment to complete necessary paperwork. Please have the attached Medical Examination for Separation/Retirement form completed at this time. Return this form to the Separations office.
- 8. You have been scheduled for a pre-separation briefing. You must report to the Family Support Center on <u>in fun 03</u> at <u>1430</u> hours. This is a mandatory appointment and you must be in uniform. You must report at least 15 minutes in advance to this appointment to complete any necessary paperwork.

- 9. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in your orderly room.
- 10. Execute the attached acknowledgment and return it to me immediately.
