AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2003-00535

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge.


Issue. Applicant was discharged for drug abuse and minor disciplinary infractions. The records indicated the applicant received an Article 15, eight Letters of Reprimand, three Letters of Counseling, had an Unfavorable Information File, and was placed on the Control Roster for his misconduct. His infractions included failing to go seven times, disobeying orders four times, sleeping on duty, driving a government vehicle without a license, underage drinking, disrespect to a superior, and using marijuana. Member also had an Enlisted Performance Report rated an overall referral "2" noting his lapses in judgment and stating he was no longer fit to serve. At the time of the discharge member consulted counsel and waived his right to submit statements in his own behalf. The DRB opined that through the unit's many administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded his misconduct was a significant departure from conduct expected of all military members. The Board reviewed the entire record and found no evidence of impropriety or inequity in this case on which to base an upgrade of discharge. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

1. I am recommending your discharge from the United States Air Force for Drug Abuse and Minor Disciplinary Infractions. The authority for this action is AFI 36-3208, paragraphs 5.54 and 5.49. If my recommendation is approved, your service will be characterized as Honorable, General or Under Other Than Honorable Conditions (UOTHC). I am recommending your service be characterized as General.

2. My reasons for this action are:

- a. On 16 Apr 00, you drove a Government Owned Vehicle (GOV) without a valid state driver's license which is a violation of AFI 31-204, paragraphs 2.0-2.1.1.4. For this action you received a Letter of Counseling (LOC) dated 21 Apr 00.
- b. On 17 Jan 01, you failed to go to Commander's Call. For this action, you received a Letter of Reprimand (LOR) undated.
- c. On 27 Mar 01, you disobeyed a direct order given by a superior. For this action, you received an LOC dated 29 Mar 01.
- d. On 28 Mar 01, you disobeyed a direct order given by a superior and were found later sleeping on duty. For these actions, you received an LOR dated 29 Mar 01.
- e. On 22 Apr 01, you failed to follow proper procedure when leaving your post for the day. For this action, you received an LOR dated 23 Apr 01.
- f. On or about 30 May 01, you consumed alcohol while being under the legal drinking age. For this action, you received an LOR dated 30 May 01.
- g. On 21 Jul 01, you were disrespectful to a superior. For this action, you received an LOR dated 31 Jul 01.
- h. On 4 Nov 02, you failed to report to your duty station at the appointed time. For this action, you received an LOC undated.

- i. On 8 Feb 03, you failed to report to your duty station. For this action, you received an LOR dated 18 Feb 03 and an Unfavorable Information File (UIF) was established.
- j. On 9 Feb 03, you failed to report to your duty station at the appointed time and disobeyed a direct order give by a superior. For this action, an AF Form 1168 dated 9 Feb 03 was completed and placed in your files.
- k. On 11-12 Feb 03, you disobeyed a direct order, failed to meet uniform standards and failed to report to your duty station at the appointed time. For these actions, you received an LOC dated 12 Feb 03.

- m. Between 26 Mar 03 and 2 Apr 03, you wrongfully used marijuana. For this action, you received an Article 15 action dated 24 Apr 03, reduction in grade from Senior Airman to Airman, 30 days of restriction to Robins AFB GA and 30 days extra duty.
- n. On 16 Apr 03, you failed to report to your duty station. For this action, you received an Article 15 action dated 24 Apr 03, reduction in grade from Senior Airman to Airman, 30 days of restriction to Robins AFB GA and 30 days extra duty.
- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction will ultimately decide whether you will be discharged or retained in the Air Force and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force.
- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult with Area Defense Counsel, 926-5852, at 1530 hours on 13 May 03. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements on your own behalf. Any statements you want the separation authority to consider must reach me within 3 workdays of notification unless you request and receive an extension for good cause. I will send the statements to the discharge authority with the case file to be considered with this recommendation. If you fail to respond, your failure will constitute a waiver of the right to submit statements on your behalf.
- 6. You have been scheduled for a medical examination. You must report to Family Practice located in Building 700A at 0900 hours on 14 May 03. You must be in uniform and on time in order to keep the scheduled appointment.
- 7. You have an appointment for an initial briefing at separations with Ms Kiper, Bldg 905, 327-7348, at 0900 hours on 15 May 03. Please bring an escort for your assistance.
