## AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2003-00432

**GENERAL:** The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of Discharge is denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge. The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

**ISSUE**: The applicant submitted no issues and requested that the review be completed based on the available service record. The Board reviewed the entire record and found no evidence of impropriety or inequity in this case on which to base an upgrade of discharge. The records indicated applicant received two Article 15s for assault and for being disrespectful in language toward a SNCO. In addition, he received four Letters of Reprimand for assault (twice), lying, providing a false official statement, and reckless driving and speeding. He also received a Letter of Admonishment for blatant disregard for military bearing, laziness, bad attitude, disrespectful to authority, and failure to conform to standards, and, three Memorandums For Record for financial irresponsibility. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative/repetitive behavior. The Board concluded the disciplinary infractions were a significant departure from the conduct expected of all military members.


**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

## 2. Coleman assets assets for this action are:


- a. On or about 18 Feb 01, you assaulted a civilian in Missoula, MT. In addition, on or about 18 Feb 01, you failed to cooperate with police officers. For this misconduct, you received a Letter of Reprimand (LOR) dated 2 Mar 01.
- b. On or about 7 May 01, you failed to pay your just debt of \$234.28 on your Government VISA account, in that you were 30 days past due. For this misconduct, you received a Delinquent Balance letter and verbal counseling dated 7 May 01.
- c. On 9 May 01, you were cited by Malmstrom law enforcement for an expired registration. For this misconduct, you received an Armed Forces Traffic Ticket dated 9 May 01.
- d. On or about 6 Jun 01, you failed to pay your just debt of \$11.10 on your Government VISA account, in that you were 30 days past due. For this misconduct, you received a Delinquent Balance letter and verbal counseling dated 6 Jun 01.

For this misconduct, you received an Article 15/UIF dated 23 Jan 03, with the following punishment: reduction to the grade of airman basic, forfeiture of \$575 pay per month for 2 months, and restriction to the limits of MAFB, MT for 30 days.
- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising Special Court-Martial jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force and any special pay, bonus, or education assistance funds may be subject to recoupment.
- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult the Area Defense Counsel, x4723, 7015 Goddard Drive, Bldg 145, Room 144 on <u>36 Feb 03</u> at 10:00. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by COB 3 Morch 03 (3 duty days) unless you request and receive an extension for good cause shown. I will send all submitted statements to the separation authority.
- 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.

- 8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208, *Administrative Separation of Airmen*, is available for your use at your orderly room.
- 9. Execute the attached acknowledgement and return it to me immediately.
