### AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2003-00478

**GENERAL:** The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

Issue 1. Applicant received a general discharge for minor disciplinary infractions. The records indicated the applicant received two Letters of Reprimand, nine Records of Individual Counseling and two AETC Forms 341. His misconduct included four instances of failure to go, two dress and appearance violations, four dormitory room inspection failures, a violation of Technical Training phase policies, and failure to update his locator card. A record of administrative training action indicated member was unable to consistently meet standards outside of the classroom and was unwilling to accept responsibility for his actions. At the time of the discharge processing, member submitted a statement accepting responsibility for his infractions and noting that his transition to military life was simply taking longer than it did for other members. He also noted his infractions were minor and requested to be retained. The DRB opined that through the unit's numerous administrative actions, the applicant had ample opportunities to change his negative behavior and was either unwilling or unable to do so. The Board concluded his misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was therefore found to be appropriate.

The applicant inferred he was told his discharge would automatically be upgraded in 4 months. The DRB noted this common issue, the result of miscommunication. While a discharge may be upgraded after 4 months, an upgrade is not automatic. A discharge is upgraded only if the applicant and the DRB can establish an inequity or impropriety took place at the time of discharge. In this case, none was found, so the Board denied the appeal.

**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

- 5. If you fail to consult counsel or to submit statements in your behalf, your failure will constitute a waiver of your right to do so.
- 6. You have been scheduled for a medical examination. You must report to the 81st Medical Group, Keesler AFB, at 0700 hours on \_\_\_\_// HPF94\_ for the examination. Pick up your medical records from the out patient records section and bring them with you to the exam.
- 7. Any personal information you furnish in rebuttal is covered by the Privacy Act Statement as explained in AFR 39-10, Attachment 2. A copy of AFR 39-10 is available for your use in the Military Training Flight Admin Section.
- 8. Execute the attached acknowledgment and return it to me immediately.
