AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2003-00486

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of Discharge is denied.

ISSUE: Applicant contends discharge was inequitable because it was too harsh. The records indicated the applicant received two Article 15s. The first one for being AWOL for 3 days, disobeying a lawful order, and dishonorably failing to pay his debt. The second Article 15 was for failure to go. He also received a Vacation action under the UCMJ for being AWOL again. In addition, he received one Letter of Reprimand and one Letter of Counseling, both for dereliction of duty. Applicant states that his discharge was based on one isolated incident in 87 months of service. This issue is unfounded based on the above incidents of misconduct. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.



SUBJECT: Notification Letter -- Board Hearing

1. I am recommending your discharge from the United States Air Force for Minor Disciplinary Infractions, according to AFPD 36-32 and AFI 36-3208, under the provisions of paragraph 5.49. Copies of the documents to be forwarded to the separation authority to support this recommendation are attached.

2. My reasons for this action are as follows:

- a. On 8 Jan 98 you were derelict in your duties by not completing the appropriate paperwork at your post prior to being relieved of duty, as recorded on a Letter of Reprimand, dated 11 Jan 98.
- b. On 1 Sep 98 you failed to properly utilize the Security Forces priority code, as recorded on a Letter of Counseling, dated 3 Sep 98.
 - c. You engaged in the following misconduct:
 - 1. On 19 Nov 98, without authority, you were absent from your place of duty, without authority.
 - 2. On 19 Nov 98, having knowledge of a lawful order issued by your commander, Lt. Colombia to leave the boundaries of MacDill Air Force Base, Florida, an order which it was your duty to obey, you failed to obey the lawful order of your commander by wrongfully departing the base.
 - 3. From 26 Jul 98 to 29 Nov 98, being indebted to American Express Government Services charge card in the sum of \$885.13, you dishonorably failed to pay said debt.

This misconduct was recorded on a Record of Nonjudicial Punishment, dated 10 Dec 98.


- d. On 30 Jan 99, you were absent, without authority, from your place of duty at which you were required to be, as recorded on an AF Form 366, Record of Proceedings of Vacation of Suspended Nonjudicial Punishment, dated 2 Mar 99
- e. On 25 Jun 99, without authority you failed to go at the time prescribed to your appointed place of duty, as recorded on an AF Form 3070, Record of Nonjudicial Punishment Proceedings, dated 20 Jul 99

This action could result in your separation with an under other than honorable conditions discharge. I am recommending that you receive an under honorable conditions (general) discharge. The commander exercising Special Court-Martial jurisdiction or a higher authority will make the final decision in this manner. If you are discharged, you will not be eligible for reenlistment in the Air Force and will probably be denied enlistment in any component of the armed forces.

- 4. You have the right to:
 - a. Consult legal counsel.
 - b. Present your case to an administrative discharge board.
 - c. Be represented by counsel at an administrative discharge board hearing.
- d. Submit statements in your own behalf in addition to, or in lieu of, the administrative discharge board hearing.
- e. Waive the above rights. You must consult legal counsel before making a decision to waive any of your rights.
- 5. You have been scheduled for a medical examination. You must report to the Physical Exams element, 6th Medical Group Hospital, on 28 July at 0900 hrs.
- 6. Military legal counsel, Captain has been obtained to assist you. His office phone is (813) 828-4455. An appointment has been scheduled for you to consult him on 27 July at 1400 hrs. Instead of the appointed counsel, you may request another, if the lawyer you request is in the active military service and is reasonably available as determined according to AFI 51-201. In addition to military counsel, you have the right to employ civilian counsel. The Air Force does not pay expenses incident to the employment of civilian counsel. Civilian counsel, if employed, must be readily available.
- 7. Confer with your counsel and reply, in writing, within 7 workdays, specifying the rights you choose to exercise. The statement must be signed in the presence of your counsel. If you waive your right to a hearing before an administrative discharge board, you may submit written statements in your own behalf. I will send the statements to the discharge authority with the case file to be considered with this recommendation. If you fail to respond, your failure will constitute a waiver of the right to the board hearing.
- 8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in the unit orderly room.
- 9. If you request a board and you fail to appear without good cause, your failure to appear constitutes a waiver of your right to be present at the hearing.
