## AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00015

**GENERAL:** The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

**FINDINGS**: Upgrade of discharge is denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge.

### **ISSUES**:

Issue 1. Applicant was discharged for minor disciplinary infractions. The records indicated the applicant received an Article 15, four Letters of Reprimand, eight Records of Individual Counseling, one Letter of Admonishment for misconduct. His infractions included nine incidents of failure to go, six incidents of sleeping on duty, two incidents of dereliction of duty, and financial irresponsibility. The record also disclosed member had difficulty with his Career Development Course, and dress and appearance. Furthermore, member had an adjustment disorder, was seen several times for intermittent depression, and was admitted to a civilian hospital for same but subsequently refused follow up therapeutic services. At the time of the discharge, applicant waived his right to consult counsel and submit statements in his own behalf. The DRB opined that through the unit's many administrative actions, the applicant had ample opportunities to change his negative behavior and was either unable or unwilling to do so. The Board concluded applicant knew right from wrong and was responsible for his actions, and therefore was held accountable for them. Additionally, existence of a character and behavior disorder does not bar separation for any other authorized reason, such as misconduct, if that reason is more appropriate; a discharge for a mental disorder is not appropriate if the airman's record supports discharge for misconduct, which in this case, it does. The Board concluded the extensive misconduct was a significant departure from conduct expected of all military members and the characterization of the discharge received by the applicant was appropriate.

Issue 2. The applicant notes the period of time that has passed since his discharge, and infers it supports an upgrade. The DRB noted that while a discharge may be upgraded after 6 months, an upgrade is not automatic. A discharge is upgraded only if the applicant and DRB can establish an inequity or impropriety took place at the time of discharge. In this case, none was found, so the Board denied the appeal.


**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

1. I am recommending your discharge from the United States Air Force for Misconduct: specifically, Minor Disciplinary Infractions. The authority for this action is Air Force Policy Directive 36-32 and Air Force Instruction 36-3208, Chapter 5, Section H, para. 5.49. If my recommendation is approved, your service will be characterized as honorable or general. I am recommending your service be characterized as general.

## 2. My reasons for this action are:

- a. You, who knew or should have known of your duties, at or near Tyndall Air Force Base, Florida, on or about 21 March 2002, were derelict in the performance of your duties in that you willfully failed to refrain from sleeping while on duty while, and did not secure the storeroom, as it was your duty to do, as evidenced by an Article 15 finalized 9 April 2002. (Atch 1a)
- b. You, who knew of your duties, at or near Tyndall Air Force Base, Florida, on or about 31 March 2002, were derelict in the performance of your duties in that you willfully failed to return to your place of duty after notifying your replacement, as it was your duty to do, as evidenced by a LOR dated 2 Apr 02. (Atch 1b)
- c. You, being indebted to Military Star Program in the sum of \$114.49 for purchases, which amount became due and payable on or about 28 March 2002, did at or near Tyndall Air Force Base, Florida, on or about 28 March 2002, dishonorably fail to pay said debt, as evidenced by a LOA dated 29 March 2002. 

- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising special court-martial jurisdiction, or a higher authority, will decide whether you will be discharged or retained in the Air Force. If you are discharged, you will be ineligible for reenlistment in the Air Force and will probably be denied enlistment in any component of the armed forces.
- 5. You have the right to submit statements on your own behalf. Any statements you want the separation authority to consider must reach me within three (3) workdays unless you request and receive an extension, in writing, for showing good cause. I will send them to the separation authority.
- 6. If you fail to consult counsel or submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 7. You have been scheduled for a medical records check as part of this discharge process. You must report to the NCOIC, Physical Examinations, Building 1465 (3-7673), Monday, Tuesday, Thursday or Friday between 1330 and 1500 to complete this medical records check.
- 8. You have been scheduled for a separations briefing. You must report to 325 MSS/DPMAR (Separations) section at <u>0730</u> on <u>244pro2</u>
- 9. Any personal information you furnish in rebuttal is covered by the Privacy Act. A copy of AFI 36-3208 is available for your use in the unit personnel office.
- 10. Execute the attached acknowledgment and return it to me immediately.
