AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00026

GENERAL: The applicant appeals for upgrade of discharge to honorable, change the reason and authority for the discharge, and, to change the reenlistment code.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of Discharge, change of reason and authority for discharge, and change of reenlistment code are denied.

ISSUE: Applicant contends discharge was inequitable because it was too harsh and he is now in the Army National Guard. The records indicated the applicant received an Article 15, two Letters of Reprimand, and two Letters of Counseling. In addition, he received a Vacation action under the UCMJ. The fact that the applicant is now in the Army National Guard does not negate the misconduct which characterized his period of service in the Air Force. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

1. I am recommending your discharge from the United States Air Force for a pattern of misconduct prejudicial to good order and discipline. The authority for this action is AFPD 36-32 and AFI 36-3208 in accordance with paragraph 5.50.2. If my recommendation is approved, your service will be characterized as honorable or general. I am recommending that your service be characterized as general.

2. My reasons for this action are:

- a. On or about 2 Jun 98, you were derelict in your duty, to wit: you rode an off the road dirt bike to work and could not show proof of motor cycle training in violation of AFI 32-204, GFAFB, Sup 1. For this misconduct, you received an LOR dated 10 Jun 98 and an Unfavorable Information File entry was made. (Attachment A)
- b. On or about 29 May 98, you were derelict in your duties in that you failed to complete your CDC's. For this misconduct, you received an LOC dated 29 May 98. (Attachment B)
- c. On or about 5 Feb 98, while returning a government truck to the vehicle barn in the Weapons Storage Area, you did knowingly abuse the vehicle by spinning the tires while entering the vehicle barn. For this misconduct, you received a LOR dated 11 Feb 98 and an Unfavorable Information File entry was made and you were placed on the Control Roster. (Attachment C)
