AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00027

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of Discharge is denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge. The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

ISSUE: The applicant submitted no issues and requested that the review be completed based on the available service record. The Board reviewed the entire record and found no evidence of impropriety or inequity in this case on which to base an upgrade of discharge. The records indicated applicant received an Article 15, five Letters of Reprimand and four Letters of Counseling. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative/repetitive behavior. The Board concluded the disciplinary infractions were a significant departure from the conduct expected of all military members.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

I am recommending that your service be characterized as general.


2. My reasons for this action are:

- a. On or about 11 Apr 00, you were derelict in the performance of your duties by maintaining a damaged M203 weapon and not notifying your chain of command at a deployed location. For this misconduct, you received a Letter of Reprimand (LOR), dated 19 Apr 00. (Attachment A)
- b. On or about 14 Apr 00, you were overdrawn on your Fleet MasterCard account. For this, you received a Letter of Counseling (LOC), dated 17 Apr 00. (Attachment B)
- c. On 7 Apr 00, you failed to go to your appointed place of duty, to wit: guardmount, at the prescribed time. For this misconduct, you received a LOR, dated 7 Apr 00. (Attachment C)
- d. On or about 22 Mar 00, you failed to go to your appointed place of duty, to wit: guardmount, at the prescribed time. For this misconduct, you received a LOR dated 23 Mar 00. (Attachment D)
- e. On or about 3 Jan 00, you failed to go to a mandatory medical appointment at the time prescribed. For this misconduct, you received an LOR dated 5 Jan 00 and it was placed in an existing Unfavorable Information File. (Attachment E)
- f. On or about 14 Nov 99, you willfully damaged military property of the United States. For this misconduct, you received an Article 15, dated 9 Dec 99. Punishment consisted of suspended reduction to the grade of airman basic, forfeiture of \$200.00 pay and 15 days extra duty. (Attachment F)
- g. On or about 16 Nov 99, you failed to report as ordered to your Operations Superintendent's office prior to going home for the day. For this misconduct, you received a LOC dated 19 Nov 99. (Attachment G)

- h. On or about 24 Oct 99, you failed to go to your appointed place of duty, to wit: guardmount, at the prescribed time. For this misconduct, you received a LOR dated 30 Oct 99. (Attachment H)
- i. On or about 10 Oct 99, you failed to obey a lawful order by being late for a mandatory appointment. For this misconduct, you received a LOC dated 10 Oct 99. (Attachment I)
- j. On or about 26 Aug 99, you failed to obey a lawful order by being late for a mandatory appointment. For this misconduct, you received a LOC dated 26 Aug 99. (Attachment J)
- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or higher authority will decide whether you will be discharged or retained in the Air Force and if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force.
- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. You have been scheduled an appointment at the Office of the Area Defense Counsel at Building 306 on 5 MAY oo at 9900 hours. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by hours unless you request and receive an extension for good cause shown. I will send them to the separation authority.
- 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 8. Deliver to me immediately your mintary identification. I have requested that temporary identification cards be issued IAW AFI 36-3026(I), paragraph 4.2. You will report to me by COB 5 May av , to verify that issuance of Temporary Identification Card(s) has been accomplished.
- 9. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A Privacy Act statement is attached. A copy of AFI 36-3208 is available for your use in the squadron orderly room.
