### AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00083

**GENERAL:** The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

**FINDINGS**: Upgrade of Discharge is denied.

ISSUE: Applicant does not contest his discharge. He states that he would like to receive his G.I. Bill benefits. The records indicated the applicant received an Article 15, one Letter of Reprimand, one Letter of Admonishment, and a Vacation action under the UCMJ for stealing. The DRB opined that through these administrative actions, the applicant had ample opportunities to change her negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate. The applicant cited her desire to receive the G.I. Bill benefits as justification for upgrade. The DRB noted that when the applicant applied for these benefits, she understood she must receive an Honorable discharge to receive future educational entitlements. The Board was sympathetic to the impact the loss of these benefits was having on the applicant, but this is not a matter of inequity or impropriety which would warrant an upgrade.

**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.


1. I am recommending your discharge from the United States Air Force for Conduct Prejudicial to Good order and Discipline. The Authority for this is AFPD 36-32 and AFI 36-3208, Paragraph 5.50.2. If my recommendation is approved, your service will be characterized as Honorable or General. I am recommending your service be characterized as General.

## 2. My reasons for this action are:

- a. On or about 06 January 1999, you returned an APS Elph Camera valued at approximately \$285.00 to the Base Exchange without a receipt. You returned this item on numerous occasions and became suspect of impropriety on your part. Although you were not found guilty on this account your actions placed your integrity in question and you received a Letter of Admonishment.
- b. On 24 March 1999, you did at or near Lackland Air Force Base steal a camera of a value of approximately \$345.95, the property of the Lackland Air Force Base Exchange. This was a violation of the UCMJ, Article 121. You accepted an Article 15 for theft. As a result you were reduced to the grade of E-2 with a new date of rank of 05 May 1999 which was suspended until 03 November 1999 unless sooner vacated. One day of correctional custody was also imposed and an Unfavorable Information File (UIF) was established.
- c. On 20 September 1999, the Montgomery County Sheriffs Department in or near the city of Woodlands TX arrested you for shoplifting. You stole from the J.C. Penny department store items valued at a total cost of \$150.00. This is a violation of Article 121 of the UCMJ. You committed this act while still under suspension from the 24 Mar 99 incident at the Lackland AFB Exchange. The suspension was therefore vacated and a Letter of Reprimand was given and filed in existing UIF.
- 3. Copies of documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force. If you are discharged, you will be ineligible for reenlistment in the Air Force.

- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult the Area Defense Counsel (ADC) at Bldg 1000 on 2 Nov 99 at 1000. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by <u>05 Nov. 99</u> unless you request and receive an extension for good cause shown. I will send them to the separation authority.
- 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 7. You will be required to take a medical examination. You must report to Bldg. 6612, Rm 502, Monday through Friday, between 1300 1500 hours with your medical, immunization, and dental records.
- 8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in the Unit Orderly Room.
