AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00102

GENERAL: The applicant appeals for upgrade of discharge to honorable and to change the reason and authority for the discharge.

The applicant appeared and testified before the Discharge Review Board (DRB), without counsel, at Travis AFB CA via video-teleconference with Andrews AFB MD on 19 October 2004. The following additional exhibits were submitted at the hearing:

Exhibit 5: Applicant's contentions

Exhibit 6: VA Medical Progress Report, 20 Sep 04

Exhibit 7: VA Entitlement Pkg, 25 May 04

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: The Board grants the requested relief. The discharge is upgraded to honorable.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an impropriety that would justify a change of discharge. However, based upon the record and evidence provided by applicant, the Board finds the applicant's character and reason for discharge inequitable.

ISSUE: After a thorough and complete consideration of the information submitted by applicant and contained in the records, the Board concluded there was sufficient mitigation to substantiate upgrade of the discharge. Specifically, the Board found the characterization too harsh. The applicant received four Letters of Reprimand, and one Record of Individual Counseling. The misconduct included damage to government property, unprofessional behavior, late for duty, and speeding. The Board opined that the member's underlying adjustment disorder at the time bore some causal relationship with his instances of misconduct.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

However, in view of the foregoing findings, the Board further concludes that the overall quality of applicant's service is more accurately reflected by an Honorable discharge and change of reason for discharge to Personality Disorder, SPD Code, JFX, under the provisions of Title 10, USC 1553.
