AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00106

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge.

ISSUE: Applicant was discharged for minor disciplinary infractions. The records indicated the applicant received two Articles 15, five Letters of Reprimand, and five Records of Individual Counseling for misconduct. His infractions included eight incidents of being late for work, failure to go, or leaving his duty section without permission. He also lost his line badge at least twice, had two incidents of dereliction of duty, multiple instances of misuse of a government vehicle, a failed dormitory room inspection, and a dress and appearance violation. After evaluation by the Mental Health staff regarding member's habitual lateness, it was only determined he had a further unspecified occupational problem. The DRB opined that through the unit's many administrative actions, the applicant had ample opportunities to change his negative behavior and was unable or unwilling to do so. The Board further noted member was age 19 to 21 at the time of his misconduct, the same age as other first-term airmen who successfully complete their enlistments without misconduct. And, there was no evidence applicant was immature or didn't know right from wrong. The Board concluded his misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was thus found to be appropriate.


CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.


2. My reasons for this action are:

For this misconduct you received an Article 15.
- c. On or about 1 May 1997, you failed to go at the time prescribed to your appointed place of duty, and on or about 1 May 1997, you were derelict in the performance of your duties in that you failed to maintain your hair to the appropriate standards. For this misconduct you received an Article 15.

- h. On or about 19 July 1996, you were late reporting for duty. For this misconduct you received a Letter of Counseling.
- i. On or about 18 July 1996, you failed to report to duty at the specified time. For this misconduct you received a Letter of Counseling.
- j. On or about 16 July 1996, you failed to report to duty at the specified time. For this misconduct you received a Letter of Counseling.

Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. - 6. You have been scheduled for a medical examination. You must report to the base hospital, physical exams, at <u>0815</u> on <u>9 June 97</u>.
- 7. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in the unit orderly room.
- 8. Execute the attached acknowledgment and return it to me immediately.
