AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00115

GENERAL: The applicant appeals for upgrade of discharge to honorable and to change the reason and authority for the discharge, and to change the reenlistment code.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of Discharge and change of reason and authority for discharge, and change of reenlistment code are denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge.

ISSUE: The applicant received a General discharge (Misconduct - Minor Disciplinary Infractions) and submitted one issue:


Issue 1. The applicant cited his desire to join the United States Army as justification for upgrade. The DRB noted this is not a matter of inequity or impropriety which would warrant an upgrade and found no other evidence of impropriety or inequity in this case on which to base an upgrade of discharge.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

SUBJECT: Notification Memorandum

1. I am recommending your discharge from the United States Air Force for minor disciplinary infractions. The authority for my action is AFPD 36-32 and AFI 36-3208, paragraph 5.49, Minor Disciplinary Infractions. I recommend an Under Honorable Conditions (General) discharge. The specific reasons for the proposed discharge and acts or conditions on which the recommendation is based are contained in Attachment 2.

2. My reason for this action is:

- a. On or about 9 Jan 02, you failed to report to your appointed place of duty and then made a false statement to an NCO when questioned. As a result, you received a Letter of Counseling (LOC), dated 14 Jan 02.
- b. On or about 10 Jan 02, while posted as a sentinel, you were found sleeping upon your post. As a result, you received an Article 15, dated 22 Jan 02. Your punishment consisted of a suspended reduction in rank to Airman and a reprimand. Additionally, an Unfavorable Information File (UIF) was created.
- c. Between on or about 26 Jan 02 and on or about 27 Jan 02, on two separate occasions, you failed to go to your appointed place of duty at the time prescribed. As a result, the suspended reduction in rank to Airman, from the Article 15 dated 22 Jan 02, was vacated on 21 Feb 02.
- d. On or about 15 May 02, you wrote a check in the amount \$36.84 to the Kunsan AB Commissary, which was later returned because you had insufficient funds in your bank account to cover the transaction. As a result, you received a LOR, dated 12 Aug 02, which was file in your existing UIF.
- e. On or about 16 May 02, you reported to work with an excessive amount of facial hair. As a result, you received a LOR, dated 4 Jun 02, which was filed in your existing UIF.
- f. On or about 16 May 02, on several occasions, you used provoking speeches and gestures and indecent language towards SrA when he gave you instructions. As a result, you received a LOR, dated 4 Jun 02, which was filed in your existing UIF.
- g. Between on or about 2 May 02 and 4 Jun 02, you wrote ten separate checks in the total amount of \$1,331.32, for the procurement of lawful currency, and thereafter dishonorably failed to maintain sufficient funds in Hancock Bank for payment of the checks upon presentment for payment. As a result, you received an Article 15, dated 3 Sep 02, which was filed in your existing UIF. Your punishment consisted of reduction to the rank of Airman Basic and 30 days extra duty.

- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising Special Court-Martial jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force, and if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force and any special pay, bonus, or education assistance funds may be subject to recoupment.
- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. You are scheduled for an appointment on with the ADC, Capt at Building 301 on 35 Sep at _______ at ______. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by <u>30 Sep 02</u>(3 duty days) unless you request and receive an extension for good cause shown. I will send them to the separation authority.
- 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 7. You are scheduled for a medical examination with Physical Exams on 35 Sep , 3002 at 1640. Report 30 minutes prior to your appointment to Physical Exams to complete a SF 88. Ensure that you complete this form prior to your appointment. Complete all follow up appointments.
- 8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in your unit orderly room.
