AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00214

GENERAL: The applicant appeals for upgrade of discharge to honorable, to change the reason and authority for the discharge, and to change the reenlistment code.

The applicant was scheduled for a personal appearance before the Discharge Review Board (DRB) on October 22, 2004, via Video-Teleconference between Travis AFB, CA, and Andrews AFB, MD, but failed to appear or contact the DRB.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge, change of reason and authority for discharge, and change of reenlistment code are denied. The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge

ISSUE:

Applicant contends he would like to reenlist in the Air Force and make it a career, that he was raised in a very disciplined and structured family and hung out with the wrong people while he was in the Air Force, and that he is wiser and more mature now and would like the opportunity to show his family, the Air Force, and himself that a person can grow up and change. The records indicated the applicant received three Article 15s, four Letters of Reprimand, and two Records of Individual Counseling for misconduct that included failure to go, repeatedly being late for duty and mandatory appointments, dereliction of duty, a speeding ticket, and two referral Enlisted Performance Reports . The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge, reason and authority for discharge, and reenlistment code should not be changed.

I am writing this letter in hopes of reenlisting into the U.S. Air Force. My name is the Air Force right out of high school at the age of 18. I was discharged early at the age of 21. I recently tried to reenlist and was told by the recruiter that my discharge was a general. I respectively ask that my discharge be changed to an honorable. My recruiter told me to acquire these forms and respectfully submit them to you in hopes of trying to go back in the U.S. Air Force. I come from a very good family. I've never been away from home by myself and unsupervised. I was taught to be honest, respectful and trustworthy. I never had a problem in basic training. I received the AIR FORCE TRAINING RIBBON in basic training. My career field upon graduation from basic was a B1-B2-B52 AEROSPACE MAINTENANCE APPRENTICE. While stationed at Barksdale Air Force Base, La., SECOND MAINTENANCE QUADRON, MAINTENANCE FLIGHT, I acquired my JOURNEYMEN and was an AIRMEN 1ST CLASS. I also received the AIR FORCE OUTSTANDING UNIT AWARD. When I arrived at Barksdale Air Force Base, I lived on base for 2 years. I then moved off base and shared an apartment with a roommate in the miltary police. First of all, growing up in my mother and fathers' home, it was a

very disciplined and structured, NO drinking, NO partying. In high school I played sports, my grades were good. While in high school, I also entered into a trade school, in which I graduated as a medical assistant. My ASVAB scores were above normal. I have no criminal records.

My problem was not on the job performing my duties. My commander and my first sargeant was happy with my job perfomance. My problem was hanging out with the wrong people,going to bars, drinking and showing up for work late and being counseled. I have no excuse for my actions to the U.S. Air Force, my commander, my sargeant, or my fellow soldiers or family. I no longer drink or hang out with the wrong people. I should have listened to my father and hung around with more positive and motivated people. I had my chances,my commander warned me and told me what was going to happen and that the only reason I stayed in as long as I did was because my job performance was good. He once told me that if he could keep me on the base 24-7 I would be ok.

I never experienced any type of night life while I was at home and growing up. I realize what I've done now that I'm older and wiser. I've been working in construction ever since I've gotten out. I've missed the Air force everyday. I would like to go back in and make a career of it.

I was young, 18 years old and I knew it all, but I knew nothing. I would like the opportunity to show my family, the Air Force, and me that a person can grow up and change. I'm mature, I won't make the same mistake again and would respectfully like an opportunity to appeal my general discharge at your earliest convenience and place.



8. If you fail to consult counsel or fail to submit statements in your behalf, you will waive the right to do so.
