## AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00242

**GENERAL:** The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

**FINDINGS**: Upgrade of discharge is approved.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an impropriety that would justify a change of discharge. However, based upon the record the Board finds the applicant's discharge inequitable.

**ISSUE**: The applicant submitted no issues and requested that the review be completed based on the available service record. The records indicated applicant received an Article 15, one Letter of Reprimand, and three AETC Form 341s for various acts of misconduct. The Board noticed that the applicant did not receive any further misconduct between the issuance of the Article 15 and the Commander's Notification letter. Also, if the command would not have waited for over a month to process the notification, the applicant could have been discharged as an Entry Level Separation. The DRB did not condone the misconduct by the applicant; however, the discharge is more appropriately characterized as Honorable.

**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process. However, in view of the foregoing finding, the Board further concludes that the overall quality of the applicant's service is more accurately reflected by an Honorable discharge and should be changed under the provisions of Title 10, USC 1553.

1. I am recommending your discharge from the United States Air Force for minor disciplinary infractions. The authority for this action is AFPD 36-32 and AFI 36-3208, paragraph 5.49. If my recommendation is approved, your service will be characterized as an honorable or under honorable conditions (general). I am recommending that your service be characterized as under honorable conditions (general).

## 2. My reasons for this action are:

- a. You, who knew or should have known of your duties at or near Sheppard Air Force Base, Texas, on or about 12 Jun 03, were derelict in the performance of those duties in that you willfully failed to adhere to call to quarters, failed to refrain from riding in a privately owned vehicle, failed to remain in the appropriate uniform and failed to remain within the limits of Sheppard Air Force Base, Texas, while in Phase I, as it was your duty to do. For this misconduct, you received Article 15 punishment on 9 Jul 03.
- b. You, at or near Sheppard Air Force Base TX, on 27 May 03, were at the schoolhouse bus stop waiting to come back to the dorm at lunch. (383 TRS instructor) asked all the Airmen at the bus stop for their bus waivers. When asked where your bus waiver was, you lied to him a bout ha ving a waiver. You then proceeded to run a way. Then ordered you to stop and asked you for an AETC Form 341. You then gave an AETC Form 341 with fictitious information. After discovered the AETC Form 341 was false, you were sent to see the senior MTL, and continued to lie about falsifying an AETC Form 341. For this misconduct you received a Letter of Reprimand (LOR) on 28 May 03.

Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or higher authority will decide whether you will be discharged or retained in the Air Force and if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible to reenlist in the Air Force and will probably be denied enlistment in any component of the armed forces.

You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult at plug ro38, Room 110 on 25ep + 03, at 0900. You may consult civilian counsel at your own expense.

- 4. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by 3 Stot 03 0900 unless you request and receive an extension for good cause shown. I will send them to the separation authority.
- 5. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 6. You were scheduled for a separation physical on 29 55103 between the hours of 0900 and 1400 at the hospital, Bldg 1200, physical exams section.
- 7. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in building 1917, room 1A208.
- 8. Execute the attached acknowledgment and return it to me immediately.
