AIR FORCE DISCHARGE REVIEW BOARD HEARING RECORD

AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00253

GENERAL: The applicant appeals for upgrade of discharge to honorable and to change the reason and authority for the discharge.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge and change of reason and authority for discharge are denied.

ISSUE: Applicant contends discharge was inequitable because it was too harsh due to the fact that he was diagnosed with sleep apnea and severe depression. The records indicated the applicant received three Article 15s, ten Letters of Reprimand, and three Letters of Counseling for various acts of misconduct. Although some of the member's infractions (i.e., failure to go) is mitigated by his Obstructive Sleep Apnea, the gravity of the member's remaining disciplinary infractions (drunk driving, underage drinking, abuse of a prescription medication, dereliction of duty and disobeying an order) bear no causal or mitigating relationship with his medical condition. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

1. I am recommending your discharge from the United States Air Force for misconduct, specifically minor disciplinary infractions. The authority for this action is AFPD 36-32 and AFI 36-3208, paragraph 5.49. If my recommendation is approved, your service will be characterized as honorable, general, or under other than honorable conditions. I am recommending that your service be characterized as general.

2. My reasons for this action are:

- a. You, who knew of your duties at or near Fort Walton Beach, Florida, on or about 26 April 2003, were derelict in the performance of those duties in that you willfully failed to refrain from drinking alcohol while under the age of twenty-one (21), as it was your duty to do. For these offenses, you received nonjudicial punishment, dated 3 June 2003.
- b. On 26 April 2003, you operated a motor vehicle while drunk. For this offense, you received letter of reprimand, dated 29 May 2003.
- c. On 21 April 2003, your unit was notified that you had an outstanding debt of \$1,553.00 for five past-due automobile loan payments. For this offense, you received letter of reprimand, dated 29 May 2003.
- d. Between on or about 5 May 2003 and on or about 29 May 2003, you abused the prescription medication Ritalin. For this offense, you received letter of reprimand, dated 29 May 2003.
- e. On or about 21 March 2003, you reported two hours late to a mandatory ADAPT appointment. For this offense, you received letter of reprimand, dated 24 March 2003.
- f. On or about 20 March 2003, you reported late to duty. For this offense, you received letter of reprimand, dated 20 March 2003.
- g. On or about 12 February 2003 and on or about 3 March 2003, you failed to report to duty. For these offenses, you received nonjudicial punishment, dated 20 March 2003.
- h. On or about 15 January 2003, you failed to report to duty. Furthermore, you willfully disobeyed an order from the Squadron Section Commander and were derelict in the performance of your duties by failing to standby in service dress uniform at your

dorm room ready for inspection. For these offenses, you received letter of reprimand, dated 30 January 2003.

- i. On or about 8 January 2003, a dormitory inspection was conducted and your room failed with numerous violations. On 9 December 2002, a month prior to the 8 January inspection, your room was found to be in an unlivable condition. For these offenses, you received letter of reprimand, dated 13 January 2003.
- j. On or about 2 December 2002, you reported to duty in a uniform that had not been washed or pressed. For this offense, you received record of individual counseling, dated 3 December 2002.
- k. On or about 11 October 2002, you failed to reported to duty at 0700. When was sent to find you at 0815 hours you were still in bed with the your alarm clock going off. For this offense, you received a letter of reprimand, dated 16 October 2002.
- 1. On 3 October 2002 and 4 October 2002, during roll call you were informed that the JEIM section would have a uniform inspection on 7 October 2002 and maintenance badges were mandatory. On 7 October 2002, you failed the uniform inspection for failing to get a haircut, missing maintenance badges and a sloppy uniform. For these offenses, you received a record of individual counseling, dated 8 October 2002.
- m. On or about 26 July 2002, you failed to report duty at 0730 hours. was sent to find you. At 0730 you were still in bed and your quarters were in an unacceptable condition. For these offenses, you received a letter of reprimend, dated 30 July 2002.
- n. On or about 2 July 2002, you failed to report to duty at 0700 hours. You also failed to notify your supervisor you would be late. For these offenses, you received a letter of reprimand, dated 2 July 2002.
- o. On or about 14 June 2002, you reported to duty late for the third time in three weeks. For this offense, you received a record of individual counseling, dated 14 June 2002.
- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force. Special pay, bonuses, or education assistance funds may be subject to recoupment.
- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult the state of the
- 5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me within 3 workdays from today unless you request and receive an extension for good cause shown. I will send them to the separation authority.

- 6. If you fail to consult counsel or to submit statements on your own behalf, your failure will constitute a waiver of your right to do so.
- 7. You have been scheduled for an appointment with the 96th Mission Support Squadron, separations section, on 2 Jul 03 at 1030 hours.
- 8. Immediately after completion of your separations briefing report to the 96th Traffic Management Office with an Authorization Letter (provided by Separations) to schedule your TMO pickup. If you have has a TMO pickup it must be before 11 Jul 03. Immediately after your separation briefing you should go to the housing office if you reside in base quarters to schedule your pre/post inspections.
- 9. You will complete a medical examination with the 96th Medical Group, Force Health Management (formerly physical exams) located at the main hospital on the 2nd floor on 1 Jul 03 at 0715 hours.
- 10. You are required to receive a briefing from the Family Support Center prior to your separation. You were scheduled to receive your Transition Assistance Management Program (TAMP) briefing. Member has already attended.
- 11. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in your unit orderly room.
