AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00268

GENERAL: The applicant appeals for upgrade of discharge to honorable, to change the reason and authority for the discharge, and to change the reenlistment code.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge, change of reason and authority for discharge, and change of reenlistment code are denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

ISSUES:

Issues 1, 4, 6, 7 & 8. Applicant contends discharge was inequitable because it was too harsh. He also felt most of his infractions were minor, and in some cases that the evidence of record did not support the resultant disciplinary actions. The records indicated the applicant received an Article 15, six Letters of Reprimand, two Letters of Counseling, four Records of Individual Counseling, three armed forces traffic tickets, and five Memoranda for Record documenting misconduct. His infractions included multiple incidents of being late for duty, multiple traffic violations, weight management program failure, lying, misuse of a government computer, a security violation, making a false official statement, intentional discharge of a government firearm resulting in damage to government property, and driving while intoxicated for which arrested by civilian law enforcement officials. His last Enlisted Performance Report was rated an overall referral "2" and documented his failure to comply with standards, repeatedly poor decision-making, lack of understanding of and commitment to good order and discipline, and overall incompatibility with the military way of life. The DRB opined that through the unit's extensive administrative actions, the applicant had ample opportunities to change his negative behavior and was unwilling or unable to do so. The Board concluded the misconduct was a significant departure from conduct expected of all military members and the characterization of the discharge was appropriate.

Issue 2 & 3. Applicant contends that his discharge constituted punishing him twice for the same incident, and that it was unfair because he was discharged with less than a fully honorable discharge so close to his expiring term of service. Applicant also noted the long-term effects his character of service is having on his ability to find post-service employment. It should be noted that administrative separation is an action that severs the military status of an individual and characterizes his service, but is not the same as punishment rendered by a judicial or non-judicial punishment proceeding. The discharge regulations clearly gave his chain of command authority to recommend administratively discharging him based on unsuitability for further military service as a result of his serious and repeated misconduct. Facts and circumstances are different in each action and must be judged on a case-by-case basis. In doing so, a commander must consider the seriousness of the misconduct and how a member's retention might affect good order, discipline, and morale, as well as the member's age and experience, past record of service, and rehabilitative potential. Commission of a series of serious offenses over a 3-year period clearly established applicant's unsuitability for further Air Force service. All required procedures were properly followed in this case.

Issue 5. Applicant states that his discharge did not take into account the good things he did while in the service. The DRB took note of the applicant's duty performance as documented by his performance reports, letters of recommendation and other accomplishments. They found the seriousness of his willful misconduct offset any positive aspects of the applicant's duty performance. The Board concluded the discharge was appropriate for the reasons which were its basis.

Applicant further inferred that he should not be penalized indefinitely for mistakes he made when young. The DRB recognized the applicant was nearly 22 years of age when the discharge took place. However, there is no evidence he was immature or did not know right from wrong. The Board opined the applicant was as old as the vast majority of first-term members who properly adhere to the Air Force's standards of conduct and successfully complete their enlistments without misconduct. The DRB concluded that the characterization of the applicant's discharge was appropriate due to his misconduct.

The applicant cited his desire to receive the G.I. Bill benefits as justification for upgrade. The DRB noted that when the applicant applied for these benefits, he signed a statement (DD Form 2366, on January 29, 2000) that he understood he must receive an Honorable discharge to receive future educational entitlements. The Board was sympathetic to the impact the loss of these benefits was having on the applicant, but this is not a matter of inequity or impropriety which would warrant an upgrade.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

ISSUE 1:

That, when analyzed by category and individually, as to redundancy, adequacy of explanations and mis-interpretations, do not rise to the level of a reduction of an Honorable Discharge to a General Discharge and is either improper or in-equitable, And so warrants an up-grade to an Honorable Discharge.

ISSUE 2:

Since punishment had already been levied by the Commanding Authority ONCE [i.e. Letters of Reprimand, loss of driving privileges, 7 days in Jail plus a fine of \$370.00, etc] - then the SAME Commanding Authority recommends an ADDITIONAL LIFETIME penalty of a reduction from Honorable Discharge to a General Discharge. This lifetime penalty translates to a loss of G.I Bill Benefits of over \$34,000.00 and a loss an educational opportunity that I joined the USAF for, plus relegating me to low paying jobs for the rest of my life. I have a high school education and a SAT over 1200. I joined the USAF not for the \$290 per week salary but also for the opportunity to go to College. In my chosen field of Computers, a General Discharge just about eliminates my ability to qualify for any security clearance. I was not a security risk, but had a few minor misconduct problems. It is recognized that a college education will yield about \$2,000,000 in additional lifetime income and benefits. Reducing the Honorable Discharge to a General Discharge falls in the category of Cruel and Inhumane Punishment and possibly Double Jeopardy for admittedly a laundry list of mostly traffic offenses, mis-understandings and minor violations. This is unequitable, and so warrants an up-grade to an Honorable Discharge.

ISSUE 3: That waiting until almost 2 months prior to enlistment expiration to decide early discharge with a General Discharge for admittedly mostly minor offenses for an Airman whose work product is good. It should be noted that a scarce 2 months prior, I attended a Reenlistment Seminar geared to my re-enlisting.

ISSUE 5::

One should remember that this "Computer Repair Workshop" where I was working, had regular Business Hours and the personnel and equipment being maintained, serviced some 800 to 1,000 students and instructors, referred to as "Customers".

These hours are repeatedly referred to in Reprimand letters as 0700 to 1600 hours, but if the computers were "down", we were frequently on duty until 2400 or 0100 or later. This makes a 0630 physical training session a little difficult. Frequently there were short or no lunch breaks when work was on a "major crisis" for 'mission critical issues', and dictated longer hours. My total late hours were less than five (5) hours in almost 4 years. Some consideration should have been made to recognize that Smoking was not permitted. Personnel who smoked were given 10 minutes break each hour to smoke. Non-smokers were not so benefited. I am a non-smoker, and did not enjoy this benefit.

It was not an uncommon occurrence for personnel to arrive a little late for duty, especially the staff NCO's. RHP. This atmosphere permeated the work force. My work performance was always very good. Please see attached reference letter from one of my supervisors, and the staff NCO's. USAF at page 14 enclosed. Also attached as page 15 is an autographed photograph from the staff NCO's. I was a stationed in Saudi Arabia.

MISUNDERSTANDINGS:

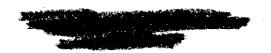

ISSUE 8::

- #1. I SOUGHT COUNSEL FROM THE BASE LEGAL OFFICER WHO TOLD ME THAT I DID NOT NEED AN ATTORNEY FOR THIS HEARING AND THAT NO ONE WOULD BE PERMITTED TO ACCOMPANY ME AT THE HEARING;. AND
- #2. NO CONSIDERATION WAS GIVEN TO THE CONTRIBUTORY NEGLIGENCE ON THE PART OF THE AIR FORCE. I WAS NOT GIVEN ADEQUATE INSTRUCTION IN THE HANDLING OF THIS WEAPON (LESS THAN A DAY INSTRUCTION ABOUT A YEAR AND A HALF AGO, FOR PURELY A CEREMONIAL ACTIVITY.) THE MOST EGREGIOUS WAS THE INSTRUCTION FROM THE ARMORER WHEN I AND OTHERS, RECEIVED THE WEAPON, WE WERE REQUIRED TO KEEP A ROUND IN THE CHAMBER AND THE SAFETY IN THE 'OFF' POSITION. THESE WEAPONS COULD FIRE ACCIDENTALLY WHEN BEING PLACED IN OR REMOVED FROM THE HOLSTER. IT IS FOR THESE REASONS THAT THE AIR FORCE SHOULD ASSUME PART OF THE RESPONSIBILITY FOR THIS 'ACCIDENT'.



CONCERNING THE FALSE STATEMENTS GIVEN BY ME, IT WAS MERELY MY OPINION OF THE HAPPENINGS WHILE I WAS NOT UNDER OATH OR WARNED ABOUT MY RIGHTS AND I WAS UNDER EXTREME STRESS UNDER THE CIRCUMSTANCES. PLEASE READ PARAGRAPH 2 OF MY STATEMENT DATED 3 APR 03: "....I WAS SCARED AND NERVOUS ABOUT WHAT HAD HAPPENED AND DID NOT WANT TO BE WRONGFULLY ACCUSED OF 'PLAYING AROUND' WITH THE WEAPON WHEN IT DISCHARGED." THIS WAS AN ACCIDENT WAITING TO HAPPEN.

I WAS TAUGHT NOT TO BE CONFRONTATIONAL, ESPECIALLY WITH SUPERIORS. LITTLE DID I REALIZE THE CONSEQUENCES FOR NOT CONTESTING MOST OF THE ABOVE COMPLAINTS.

IT IS FOR THE ABOVE REASONS THAT THE PUNISHMENT WAS HARSH IN AND OF ITSELF, AND THEN TO GET THE DOUBLE WHAMMY OF A GENERAL DISCHARGE IS INEQUITABLE. EVEN PRESIDENT CLINTON WHILE UNDER OATH, CONVICTED OF PERJURY, DID NOT GET A PENALTY THIS GREAT.

If my recommendation is approved, your service will be characterized as honorable or general. I am recommending that your service be characterized as general.

- b. On or about 2 Nov 00, you failed to report to duty at the prescribed time of 1300 hours. This is documented on a Memorandum for Record on 2 Nov 00.
- c. On or about 9 Jan 01, you failed to report to duty at the prescribed time of 0700 hours. You did not arrive daily until 0815 hours. This is documented on an AF Form 174 on 30 Jan 01.
- d. On or about 17 Jan 01, you failed to report back to duty at 1330 after lunch. You returned at 1435 stating that you had fallen asleep. This is documented on an AF Form 174 on 30 Jan 01.
- e. On or about 18 Jan 01 and 23 Jan 01, you failed to report for two scheduled dental appointments. This is documented on a Memorandum for Record on 5 Feb 01.
- f. On or about 30 Jan 01, you failed to report to duty at the prescribed time of 0800 hours. This was your third late arrival in three weeks. This is documented on an AF Form 174 on 31 Jan 01.

- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force and any special pay, bonus, or education assistance funds may be subject to recoupment.
- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult with the Goodfellow Air Force Base Area Defense Counsel on 1000 at 0300 hours in Bldg 308. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by 30003 at 0830 unless you request and receive an extension for good cause shown. I will send them to the separation authority.
- 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 7. You must report to the Physical Exams Section of the clinic during walk-in hours, Monday through Thursday from 0730-1530 hours, for your medical examination.
- 8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in the Unit Orderly Room.
