# AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

## FD-2004-00279

**GENERAL:** The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge.

**ISSUE**: Applicant contends discharge was inequitable because he states he was often tardy due to depression. The records indicated the applicant received two Article 15s, three Letters of Reprimand and three Records of Individual Counseling for misconduct for being late to work, drinking underage and using his government travel card for unofficial business. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

1. I am recommending your discharge from the United States Air Force for minor disciplinary infractions. The authority for this action is AFPD 36-32 and AFI 36-3208, paragraph 5.49. You understand that approval of this recommendation for your discharge could result in you receiving an under other than honorable conditions discharge, if the convening authority determines such characterization is warranted and directs initiation of a discharge board. I am recommending that your service be characterized as general.

2. My reasons for this action are:

a. On divers occasions between on or about 19 Mar 01 and on or about 4 Jun 01, you, who knew of your duties in the continental United States, were derelict in the performance of those duties in that you willfully failed to use your government travel card for official government purposes only, as it was your duty to do as documented by an AF Form 3070, Record of Non judicial Punishment Proceedings, dated 24 Jul 01.

b. On or about 23 Apr 01, you did, or near Pope AFB NC, without authority, fail to go at the time prescribed to your appointed place of duty, to wit: Bldg 636 as documented by an AF Form 3070, Record of Non judicial Punishment Proceedings, dated 7 May 01.

c. On or about 22 Mar 01, you arrived at work 1 hour and 15 minutes late to work without calling or letting your supervisor know you would not be in on time as documented by a Letter of Reprimand (LOR), dated 26 Mar 01.

d. On or about 2 Mar 01, you missed the bus to support 23d Fighter Group flying operations at Seymour Johnson AFB NC for the second time in the week as documented by a Letter of Reprimand (LOR), dated 3 Mar 01.

e. On or about 21 Jul 00, you were asked to show up at 1530 hours to sign out the ECM Flightline support section. You arrived 15 minutes late on four occasions as documented by an AF Form 174, Record of Individual Counseling, dated 21 Jul 00.

f. On or about 5 May 00, you were 5 minutes late for an appointment with the commander as documented by an AF Form 174, Record of Individual Counseling, dated 5 May 00.

g. On or about 5 Dec 99, you were found drinking alcohol at an apartment complex. The legal dringking age is 21, and you were not yet 21 years old as documented by a Letter of Reprimand (LOR), dated 16 Dec 99.

h. On or about 3 Dec 99, you arrived late for the 23 MXS Avionics Flight Call as documented by an AF Form 174, Record of Individual Counseling, dated 3 Dec 99.

3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The 43d Airlift Wing Commander, who exercises Special Court Martial (SPCM) jurisdiction or a higher authority, will decide whether you will be discharged or retained in the Air Force. If you are discharged, you will be ineligible for reenlistment in the Air Force.

4. You have been scheduled for a physical examination. Report to Physical Exams Room 10 in the Flight Medicine Clinic on <u>17 Aug 01</u> at <u>0945</u> hours. In addition, report to Physical Exams/Lab ASAP for HIV screening.

5. You have the right to consult counsel. Military legal counsel has been obtained to assist you. Contact (Contact (Cont

6. You have the right to submit a statement in your own behalf. Any statements you want the separation authority to consider must reach me by **20 AUFO** at **1030** hours unless you request and receive an extension for good cause shown. I will send them to the separation authority.

7. If you fail to consult counsel or to submit statements in your own behalf in three days, your failure will constitute a waiver of your right to do so.
