AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00329

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge.

ISSUE: Applicant was discharged for conduct prejudicial to good order and discipline. The records indicated the applicant received an Article 15, a Letter of Reprimand, a Record of Individual Counseling, one Letter of Counseling, and had an unfavorable Information File. His infractions were all for financial irresponsibility, with one for missing a training appointment. At one point, member was 251 days past due on a debt to Nations Bank, which totaled over \$2,000.00 at that time. The record reflects that member was sent to financial management counseling twice, but he failed to follow instructions given him in order to bring his finances under control. He also was sent to Consumer Credit Counseling for debt consolidation but failed to abide by the contractual arrangements made on his behalf. The Board opined that through the unit's administrative actions, the applicant had ample opportunities to change his negative behavior and was either unwilling or unable to do so. The Board concluded the misconduct was a significant departure from conduct expected of all military members and the characterization of the discharge received by the applicant was appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.



SUBJECT: Notification Memorandum

1. I am recommending your discharge from the United States Air Force for misconduct, specifically, a pattern of misconduct prejudicial to good order and discipline. The authority for this action is AFPD 36-32 and AFI 36-3208, paragraph 5.50.2. If my recommendation is approved, your service will be characterized as honorable or general. I am recommending that your service be characterized as general.

2. My reasons for this action are:

a. On or about 10 Mar 00, you failed to maintain sufficient funds in your bank account to cover a check, in which your wife uttered to Papa Johns Pizza place in the amount of \$11.37, as evidenced by a Letter of Reprimand, dated 18 Apr 00, (Attach 1a).

b. Between on or about, 28 Feb 00 and 29 Mar 00, you uttered worthless checks to Albertson's Grocery Store, Simnacher Health Care Agency, and the Base Commissary, and failed to maintain sufficient funds in your bank account to cover these checks, as evidenced by a Record of Individual Counseling, dated 30 Mar 00, (Attach 1b).

c. Between on or about 27 Apr 99 and 14 Dec 99, you dishonorably failed to pay just debts to Nations Bank on numerous occasions, as evidenced by an Article 15 action, dated 3 Jan 00, and an Unfavorable Information File, dated 11 Jan 00, (Attach 1c).

d. On or about 13 Sep 99, you failed to go to your appointed place of duty at the prescribed time, as evidenced by a Letter of Counseling, dated 14 Sep 99, (Attach 1d).

3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force. Special pay, bonuses, or education assistance funds may be subject to recoupment.

4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult Captain **Captain Captain** at building 600, ext. on $\rho(A)$ at $\rho(A)$ hours. You may consult civilian counsel at your own

expense.

5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me within 3 workdays from today unless you request and receive an extension for good cause shown. I will send them to the separation authority.

6. If you fail to consult counsel or to submit statements on your own behalf, your failure will constitute a waiver of your right to do so.

7. You will complete a medical examination at the 27th Medical Group on 26 Apr 00 at 0730.

8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in your unit orderly room.
