AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00349

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

ISSUE: Applicant contends discharge was inequitable because it was too harsh. The records indicated the applicant received two Article 15s, a Letter of Reprimand, and one Memorandum for Record for misconduct. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate. The DRB was pleased to see that the applicant was doing well and has a good job. However, no inequity or impropriety in his discharge was suggested or found in the course of the hearing.


CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

Dear Sir's,

My name and a better future for my family and myself. I joined the Air force in July of 2000 with 1 year and some odd months in the delayed enlistment program. My goalan joining the military was to serve my country and gain an education to be put to use later in life. After basic training and tech school, I was stationed in Wyoming. I wanted to be a good airman, but I fell short of both the Air Forces and my own expectations. Being on my own for the first time was a new experience and I found myself falling into the wrong crowd and also falling into debt. There is no excuse for my behavior that I can offer you or even myself, at that time I was out of control, and I realize that now. In 2001 I was dealing with my mother being terminally ill, and I believe that had something to do with my actions but that in no way is an excuse. My actions while in the military caused my family and myself a great deal of heartache and financial difficulty, which I have since remedied.

I was separated from active duty on 11 December 2001. I served only one year and seven months. Since my separation from the military the Wackenhut Corporation has steadily employed me with duties ranging from court security in Fort Collins Colorado to working at a Ford motor company parts distribution center as safety and security. I was married 14 June 2002 to a beautiful young woman, the financial burden I carried with me from the military was very strenuous on us as a newly married couple so after eight months of being married I decided to stop living paycheck to paycheck. I was tired of not having the money to pay the bills. I left home on 7 April 2003 to work for Group 4 Falck as a civilian contractor to the Department of Defense, working at Camp Bondsteel in Kosovo. I was GS-12 providing security as a force protection specialist for the Army. I spent one year with this detail. I have done a lot for myself since I was separated, a lot to improve myself. My wife and I belong to a great spirit filled church in Memphis, and I am ready to put the past behind me and move forward in my life. I know that what I was doing was wrong and I take full responsibility for my actions. They were wrong and if I could change them I would, but I can't and so I have to learn from them and that is all I can do. I pray to never make those mistakes again.

As you can see from my DD form 293 I am requesting that my general under honorable be changed to an honorable. I have waited this long to petition because the wrongs of my past had not been corrected, now they are and it is time to move on. I am planning on testing this fall for the Cincinnati police department and having my general under honorable changed to honorable is the first step of many that will need to be taken. I thank you for your time and consideration in this matter.
