AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00368

GENERAL: The applicant appeals for upgrade of discharge to honorable, to change the reason and authority for the discharge, and to change the reenlistment code.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge, change of reason and authority for discharge, and change of reenlistment code are denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

ISSUE:

Applicant contends discharge was inequitable because it was too harsh. The records indicated the applicant received an Article 15, four Letters of Reprimand, and one Letter of Counseling for misconduct. The misconduct included late for work, wrongly and falsely making fraudulent military identification cards and making a false official statement. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

SUBJECT: Notification Memorandum

1. I am recommending your discharge from the United States Air Force for a Pattern of Misconduct (Conduct Prejudicial to Good Order and Discipline). The authority for this action is AFPD 36-32 and AFI 36-3208, para 5.50.2. If my recommendation is approved, your discharge will be characterized as either honorable or under honorable conditions (general). I am recommending an under honorable conditions (general) discharge.

2. My reasons for discharging you are:

- a. On 16 Mar 01, you failed to report to duty at the time prescribed, as evidenced by a Letter of Counseling dated 19 Mar 01. (Atch 1.1)
- b. On 27 Mar 01, you failed to report to duty at the time prescribed, as evidenced by a Letter of Reprimand dated 27 Mar 01. (Atch 1.2)
- c. On 29 Jun and 3 Jul 01, you failed to report to duty at the time prescribed, as evidenced by a Letter of Reprimand dated 5 Jul 01, establishment of an Unfavorable Information File and placement on the Control Roster. (Atch 1.3)
- d. On or about 26 Jul 01, you made a false official statement, and on or about April 01, you wrongfully and falsely made military I.D. cards for 3 individuals, as evidenced by an AF Form 3070 (Article 15) dated 29 Aug 01. (Atch 1.4)
- e. On 11 Sep 01, you failed to report to duty at the time prescribed, as evidenced by a Letter of Reprimand dated 25 Sep 01. (Atch 1.5)
- f. On 1 Oct 01, investigation revealed you wrongfully made another military identification card and made a false official statement, as evidenced by a Letter of Reprimand dated 1 Oct 01. (Atch 1.6)
- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising special court-martial convening authority (SPCM) jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force, and if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force.

- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult at Bldg 2670 on 5 oct at $\Phi93\Phi hes$ You may consult civilian counsel at your own expense.
 - 5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by 146CT &I unless you request and receive an extension for good cause shown. I will send them to the separation authority.
 - 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
 - 7. You have been scheduled for a medical examination. You must report to the Physical Examination Section, Flight Surgeon's Office, Bldg 3925 at 0730 on 50CT \$\overline{\pi}\$1 for the examination examination.
 - 8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use in the Orderly Room.
