## AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00386

**GENERAL:** The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: The Board grants the requested relief.

The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any impropriety that would justify a change of discharge. However, based upon the record, the Board finds the applicant's characterization of discharge inequitable.

ISSUE: Applicant was discharged for unsatisfactory performance and minor disciplinary infractions, with unsatisfactory performance as the primary reason. The records indicated the applicant had many infractions while in technical training, to include being late for formations and duty multiple times, room inspection failures, dress and appearance violations, sleeping on duty, refusal to do homework, and failure to obey an order. The record reflected that the first of these incidents occurred the day after member arrived on station, and he had at least 18 infractions in under a 5-month period. At the time of the discharge, member waived his right to consult counsel or submit statements on his own behalf; the records indicated he desired to be separated due to family problems, having civilian employment already arranged, and desiring to begin a college education. The DRB noted that member's commander and the base legal staff recommended his service be characterized as honorable, nevertheless, the discharge authority directed his service be characterized as under honorable conditions (general). There was no explanation for the discharge authority's decision in his memorandum directing the discharge. Furthermore, the Board noted that most of member's minor disciplinary infractions occurred within the first 180 days of service, and surmised that the chain of command could have initiated an uncharacterized Entry Level Separation, but failed to do so. Because the discharge action was begun after the first 180 days of active service, an Entry Level Separation was then no longer an available option. While the Board does not condone applicant's misconduct while in service, in view of these factors, the Board felt the discharge characterization was too harsh and inequitable, and should be upgraded to honorable.

**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

However, in view of the foregoing findings, the Board further concludes that the overall quality of applicant's service is more accurately reflected by an Honorable discharge. The applicant's characterization of discharge should be changed to honorable under the provisions of Title 10, USC 1553.

1. I am recommending your discharge from the United States Air Force for minor disciplinary infractions. The authority for this action is AFPD 36-32 and AFI 36-3208, Chapter 5, Section E, paragraph 5.26 (Unsatisfactory Duty Performance) and Section H, paragraph 5.49 (minor disciplinary infractions). The primary basis is paragraph 5.26. If my recommendation is approved, your discharge will be described as honorable or general. I am recommending that your service be characterized as honorable.

## 2. My reasons for this action are:

- a. On 24 Mar 01, you failed to stay awake while on dorm guard duty, for which you were counseled on that date. (Atch 1, Appendix A)
- b. On 21 Mar 01, you were found sleeping on duty, for which you were counseled on that date. (Atch 1, Appendix B)
- c. On 20 Mar 01, you failed to comply with 2<sup>nd</sup> Air Force Phase Program by purchasing 2 packs of cigarettes while in Phase I, for which you were counseled on that date. (Atch 1, Appendix C)
  - d. On 14 Mar 01, you received a Letter of Reprimand for the following offenses:
- i. On 9 Mar 00, you failed to get a haircut as directed, and also failed to attend First Formation. (Atch 1, Appendix D w/atchs)
- ii. On 8 Mar 00, you failed to be in compliance with AFI 36-2903 by needing a haircut. (Atch 1, Appendix D w/atchs)

- e. On 13 Feb 01, you failed to stay awake in class, for which you were counseled on 6 Mar 01. (Atch 1, Appendix E w/atch)

- i. On 28 Feb 01, you were 15 minutes late for First Formation. (Atch 1, Appendix F w/atch)
- ii. On 28 Feb 01, you arrived in an unserviceable (extremely wrinkled) uniform, and it was discovered that you had seven other negative entries in your collateral training folder. (Atch 1, Appendix F w/atch)
- g. On 26 Jan 01, you had an AFI 36-2903 violation, for which you were counseled on that date. (Atch 1, Appendix G)
- h. On 22 Jan 01, you refused to do your assigned Block III homework, for which you were counseled on that date. (Atch 1, Appendix H)
- i. On 16 Jan 01, you were absent from a mandatory formation, for which you were counseled on 22 Jan 01. (Atch 1, Appendix I w/atch)
- j. On 6 Dec 00, you had a room failure, for which you were counseled on 12 Dec 00. (Atch 1, Appendix J w/atch)
- k. On 4 Dec 00, you failed to have your military ID on your person, for which you were counseled on that date. (Atch 1, Appendix K)
- 1. On 30 Nov 00, you were late or missing from Second Formation, for which you were counseled on that date. (Atch 1, Appendix L)
- m. On 21 Nov 00, you were 10 minutes late for a briefing, for which you were counseled on that date. (Atch 1, Appendix M)
- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or higher will decide whether you will be discharged or retained in the Air Force, and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force. Any special pay, bonuses, or education assistance funds may be subject to recoupment.
- 4. You have the right to consult legal counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult \_\_\_\_\_\_ at Bldg 0701, Room 102, on \_\_\_\_\_ TBD \_\_\_\_ at \_\_\_ TBD \_\_\_ hours. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements on your own behalf. Any statements you want the separation authority to consider must reach me by 24 Apr-01 by 1630 hours unless you request and receive an extension for good cause shown. I will send them to the separation authority.
- 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
