AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

CASE NUMBER

FD-2004-00430

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

ISSUES:

Issue 1. Applicant contends discharge was inequitable because it was too harsh. The records indicated the applicant received an Article 15, a vacation action, one Letter of Reprimand, one Letter of Counseling, two Records of Individual Counseling, and a traffic ticket. His misconduct included speeding, failure to obey an order, driving with suspended driving privileges, transmitting pornographic images and sexually explicit video files via a government computer, and late for work on multiple occasions. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The characterization of the discharge received by the applicant was found to be appropriate.

Issues 2 and 3. Applicant states that his discharge did not take into account the good things he did while in the service. The DRB took note of the applicant's duty performance as documented by his performance report and other accomplishments. They found the seriousness of the willful misconduct offset any positive aspects of the applicant's duty performance. The Board concluded the discharge was appropriate for the reasons which were the basis for this case.

Issue 4. The applicant cited his desire to receive the G.I. Bill benefits as justification for upgrade. The DRB noted that when the applicant applied for these benefits, he signed a statement (DD Form 2366, on October 29, 2001) that he understood he must receive an Honorable discharge to receive future educational entitlements. The Board was sympathetic to the impact the loss of these benefits was having on the applicant, but this is not a matter of inequity or impropriety which would warrant an upgrade.

Issue 5. Applicant contends that he should not be penalized indefinitely for a mistake he made when young. The DRB recognized the applicant was 20-21 years of age when the discharge took place. However, there is no evidence he was immature or did not know right from wrong. The Board opined the applicant was older than the vast majority of first-term members who properly adhere to the Air Force's standards of conduct. The DRB concluded that the characterization of the applicant's discharge was appropriate due to the misconduct.


CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

1. I am recommending your discharge from the United States Air Force for Misconduct: Minor Disciplinary Infractions, in accordance with AFPD 36-32 and AFI 36-3208, paragraph 5.49. If my recommendation is approved, your service may be characterized as either honorable or general. I am recommending that your service be characterized as general.

2. My reasons for this action are:

- a. You did, at or near McConnell Air Force Base, Kansas, on or about 11 Jul 02, without authority, fail to go to two scheduled appointments, as it was your duty to do. For this incident, you received a Letter of Counseling (LOC), dated 11 Jul 02.
- b. You, who knew or should have known of your duties, at McConnell Air Force Base, Kansas, on or about 17 Mar 03, were derelict in the performance of those duties in that you failed to obey the posted speed limit and drove on a suspended license, as it was your duty to do. For this incident, you received an Armed Forces Traffic Ticket (DD Form 1408) and your base driving privileges were revoked for two years, as evidenced by a Revocation Notice, dated 17 Mar 03.
- c. You did, at or near McConnell Air Force Base, Kansas, on or about 18 Mar 03, without authority, fail to go to your appointed place of duty, as it was your duty to do. For this incident, you received a Record of Individual Counseling (RIC), dated 20 March 2003.
- d. You did, at or near McConnell Air Force Base, Kansas, on or about 17 Apr 03, without authority, fail to go to your appointed place of duty, as it was your duty to do. You arrived at work only after a supervisor came to your room and woke you up. For this incident, you received a RIC, dated 17 Apr 03.
- e. You did, at or near McConnell Air Force Base, Kansas, on or about 10 Aug 03, violate a lawful general regulation, to wit:, Air Force Instruction 33-129, Paragraphs 6.1.1 and 6.1.3, dated 4 Apr 01, by wrongfully transmitting pornographic images and sexually explicit video files via your government computer (0008A10FB577). For this incident, you received an Article 15, as evidenced by AF Form 3070, dated 24 Sep 03.
- f. You did, at or near McConnell Air Force Base, Kansas, on or about 3 Feb 04, violate a lawful order issued by Colonel to wit: not to operate a motor vehicle on base or words to that effect, an order which it was your duty to obey, when you wrongfully operated your personal vehicle on base. For this incident, the suspended reduction to the grade of Airman (punishment from the Article 15, dated 24 Sep 03) was Vacated, as evidenced by AF Form 366, 30 Mar 04.

- g. You did, at or near McConnell Air Force Base, Kansas, on or about 29 Feb 04, violate a lawful order issued by Colonel Herman Hicks, to wit: not to operate a motor vehicle on base or words to that effect, an order which it was your duty to obey, when you wrongfully operated a motor vehicle (MOPED) on base. For this incident, you received a Letter of Reprimand (LOR), dated 7 Apr 04.
- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction, or higher authority, will decide whether you will be discharged or retained in the United States Air Force and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force and any special pay, bonus, or education assistance funds may be subject to recoupment. The separation authority will make the findings and recommendations required under 10 U.S.C. § 2005(g).
- 4. You have the right to consult counsel. Military legal counsel has been obtained to assist you, at no expense to you. I have made an appointment for you to consult with the Area Defense Counsel (ADC) at McConnell Air Force Base, Kansas, on 2674764, at 1500 hours. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by 1 Jun ou, at 1630 hours, unless you request and receive an extension for good cause shown. I will send them to the separation authority.
- 6. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so:
- 7. You have been scheduled for a mandatory medical examination. You must report to 22d Medical Squadron Public Health Section, 57950 Leavenworth St on 3477404, at 1700-1400 hours for the examination. Take your medical records with you.
- 8. Any personal information you furnish in rebuttal is covered by the Privacy Act of 1974. A copy of AFI 36-3208 is available for your use at the First Sergeant's Office.
- 9. Execute the attached acknowledgment and return it to me immediately.
