AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00432

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant appeared and testified with counsel, it of the Veterans of Foreign Wars, before the Discharge Review Board (DRB),), at Andrews AFB, MD, on 28 Apr 2005. The applicant's aunt, also testified on the applicant's behalf.

The following additional exhibits were submitted at the hearing:

Exhibit #5: Five character reference letters

Exhibit #6: City of Long Beach, NJ, Police Report

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: The applicant received a Bad Conduct Discharge, a punitive discharge, as part of her sentence resulting from a Special Court-Martial conviction. Under the provisions of Section 1553, 10 USC, the only basis for a change of a Bad Conduct discharge is elemency. The applicant presented evidence which the DRB opined warranted granting elemency and the discharge is upgraded to general.

CONCLUSIONS: The DRB concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process. However, after a thorough review of the circumstances of the case and applicant's post-service accomplishments, the DRB determined that clemency in the form of an upgrade of applicant's discharge to general was appropriate.
