AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00434

GENERAL: The applicant appeals for upgrade of discharge to honorable, change the reason and authority for the discharge, and change the reenlistment code.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge, change of reason and authority for discharge, and change of reenlistment code are denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

ISSUE: Applicant does not contest his discharge. He indicates that since his discharge, he has graduated from college and he would like to join another branch of Service. The records indicated the applicant received a Special Court Martial for making a false written statement to deceive a licensed firearms dealer in order to purchase a firearm; leaving his appointed place of duty; wrongfully communicated a threat to kill two service members; disobeying a lawful order; being disrespectful to two noncommissioned officers, and for willfully damaging government property while in his cell. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

I write this letter to you in the hope of getting a discharge upgrade so that I my be privileged enough to stand beside my brothers in the protection of our homeland. I had previously served in the USAF but was discharged "General Under Honorable Conditions" and now ask for your help in getting a better discharge so that I may be able to serve in the USMC or USA. I ask that you read this letter and consider my words carefully, even though they are just words and can't show how much these things mean they are all I can offer without you being me. I thank you for your time.

I was blessed enough to be able to serve in the worlds greatest airpower our very own United States Air Force two years ago. I had given everything that I could have and more, I was the first to work, the last to leave, and I worked through my lunches and breaks. In my spare time I went to college so that I might educate my mind and make more informed decisions that I could use to help in my duties were I received an A in every course I took. I received top graduate in technical school, had the fastest time of completion, and the best scores for my CDC's "Career Development Courses" because I dedicated every moment of my time to my duties as an armed forces member. The feelings of pride and honor that manifested themselves to be able to serve this great nation are unexplainable, it was not a job but rather my life and my vary reason to exist.

Then one day a made an uniformed decision that forever changed everything. I'm not able to own firearm's so I had a friend buy one for me because I didn't think that it was a big deal, being that I was in the military and carried a M-16 at times. I turned the firearm into the armory immediately upon it's purchase and proceeded the next day to get the proper approval and forms from my 1st Sergeant. It turned out that it was a larger situation than I had thought; I honestly didn't think it was going to be a problem. I had checked the firearm into the proper authorities and had proceeded to get all the proper paperwork and authorizations complete. I thought that at the very worst they would just tell me that I'm not to be in possession of a civilian weapon and return it to the individual from whom it was purchased. This was not the case, I was informed that ignorance wasn't an excuse and that I would be sent to a special court martial.

The situation continued to escalate when I was told by my appointed defense counsel that no matter what happened I would not be able to stay in the service of my country. The devastation that fell upon me is like no other that I've ever felt in my entire life, I was breathing but not alive. I was told that it would be an Honorable discharge but still a discharge and it devastated me to a point that I didn't even know existed. I didn't mean the things I said or to be disrespectful on the way out, but it hurt so bad, and I just couldn't bare it. I received all of my other charges except the first "Conspiracy to illegally purchase a firearm" after I was told I would be discharged. There are no excuses and what I did was wrong but it is done, if I could change it I would but I am unable. Even now two years later I cry as I write this letter in memory of what was.

I was devastated to a point that words can't describe when I was informed that I would not be able to serve my country. I made some bad decisions and got into some trouble on my way out. I just felt like my very soul and reason for walking this world were stripped away, but still there are no excuses.

They didn't discharge me through the court martial but rather administratively after

wards. Since my discharge from the USAF I've went to school were I received a 3.89 GPA, Student of the Course for advanced electrical, Director's list, and perfect attendance through everything. I grew a lot going to school five hours a day, five days a week and still making a living in a strange town. There were times were I would go from school to different part time jobs I had pieced together to make a full time job back to back to were I would be up for three days straight non-stop working. I also run six miles every other day and the days that I don't run I lift weights so that I may stay in peak physical condition, as is my saying of strong body, mind, and spirit.

There are no excuses for the things that I have done, but they are done and no matter how hard I try or how bad my stomach turns I can't undo what is done, all I can do is ask for forgiveness. I ask that you carefully consider my plea and if it is within your will I ask that you would grant me an upgrade so that I may be able to apply for entry into the worlds greatest fighting force our very own United States Marine Corps or United States Army so that I my have the privilege to stand beside my brothers in the protection of our freedom. I know that I'm not worthy enough to bear this great honor but I ask that you consider it so that if I may be so blessed that I may also make a stand with our troops.

5. You have the right to submit statements on your own behalf. Any statements you want the separation authority to consider must reach me within **3 duty days** from today unless you request and receive an extension for good cause shown. I will send them to the separation authority.

6. If you fail to consult counsel or to submit statements on your own behalf, your failure will constitute a waiver of your right to do so.

7. You will complete a medical examination at the 27th Medical Group on $\frac{23 \text{ Apr } \sqrt{7}}{100}$ at $\frac{100}{100}$ hours.
