AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00444

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

ISSUES:

Issues 1 & 3. Applicant contends discharge was inequitable because it was too harsh and based on one isolated incident. The records indicated the applicant accepted a Chapter 4 discharge in lieu of court-martial. Member was going to be court-martialed for unauthorized sale of military property. The applicant was a member of law enforcement and is held to a higher standard. The Board concluded the misconduct was a significant departure from conduct expected of all military members--especially law enforcement. The characterization of the discharge received by the applicant was found to be appropriate.

Issue 2. Applicant states that his discharge did not take into account the good things he did while in the service. The DRB took note of the applicant's duty performance as documented by his performance reports, letters of recommendation, and other accomplishments. The DRB also recognized the fact that the applicant had served 11 years total service before the discharge was initiated, but concluded the applicant's misconduct outweighed the positive aspects of his time in the Air Force. They found the seriousness of the willful misconduct offset any positive aspects of the applicant's duty performance. The Board concluded the discharge was appropriate for the reasons which were the basis for this case.

Issue 4. The applicant contends his counsel was ineffective. This issue is without merit. The records reflect member consulted counsel and requested discharge in lieu of trial by court-martial.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.



-- ISSUES --

I was charged with wrongfully selling Government property (one Kevlar helmet and one Kevlar vest). I accepted a discharge in lieu of court martial. I believe the character of my discharge was inequitable because:

<u>Issue 1</u>: One isolated incident should not outweigh twelve years of exemplary service. I was chosen for security details for Presidents Reagan and George H.W. Bush and Secretaries of State James Baker and George Schultz. I was awarded the Air Force Commendation and Achievement Medals. My record contains not so much as an unfavorable command letter. My evaluations were uniformly outstanding.

<u>Issue 2</u>: The character of my discharge was unduly severe because it was awarded during the pendency of a large-scale investigation into the illegal sale of F-16 engines, also at Hill AFB. I was treated as if I were a part of that investigation. In actuality my case had nothing whatsoever to do with the investigation, but the investigation created a climate of heightened prosecutorial activity and public scrutiny at Hill. At any other AFB I believe my conduct would have resulted, at most, in non-judicial proceedings.

<u>Issue 3</u>: The character of my discharge was unduly harsh given the relatively minor nature of the offense.

<u>Issue 4</u>: My counsel ineffectively assisted me by failing to apprise me of the weaknesses in the Government's case. Counsel also did not point out a significant mitigating fact: I had attempted to surrender the equipment in question to proper authority, but they refused to accept it.
