AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

ISSUE: Applicant does not contest his discharge. He merely states that his discharge was due to a DWI and that he attended rehab treatment, had no further incidents, and was unemployed seeking assistance with educational benefits. The applicant was discharged for more reasons than the DWI. The records indicated the applicant received an Article 15 for assaulting his wife and an Article 15 for DWI. In addition, he received two Letters of Reprimand, a Letter of Counseling, and nine vehicle related traffic tickets. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings, the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

1. I am recommending your discharge from the United States Air Force for Misconduct according to AFR 39-10, under the provisions of 5-46, Minor Disciplinary Infractions. Copies of the documents to be forwarded to the separation authority to support this recommendation are attached.

2. My reason for this action is your pattern of minor disciplinary infractions. Specifically:

a. On 11 Jun 87, you parked your privately owned vehicle (POV) in a no parking area. As a result, you received a traffic citation (Tab 1-1).

b. On or about 30 Jun 87, you let your NCO Club Account become 60 days delinquent. As a result, you were counseled on 4 Aug 87 (Tab 1-2).

c. On 2 Aug 87, you unlawfully struck your wife on the face with your hand and in the abdomen with your fist. As a result, you received an Article 15 on 19 Aug 87 and reduction to AlC (suspended) (Tab 1-3).

d. On 7 Sep 87, you operated your vehicle with an expired American Registration. As a result, you were issued a traffic citation (Tab 1-4).

e. On 18 Sep 87, you operated your POV with an expired vehicle registration. As a result, you were issued a traffic citation (Tab 1-5).

f. On 15 Jan 88, you improperly backed your POV. As a result, you were issued a traffic citation (Tab 1-6).

g. Between 19 - 22 Dec 87, you failed to attend a scheduled OJT Supervisors' Course. As a result, you received a Letter of Reprimand (LOR) on 1 Feb 88 (Tab 1-7).

h. On 3 Oct 88, your room failed to meet inspection requirements. As a result, you received an LOR on 5 Oct 88 (Tab 1-8).

j. On 8 Mar 89, you parked your POV in a reserved parking slot. As a result, you were issued a traffic citation (Tab 1-10).

k. On 21 Apr 89, you were issued a traffic citation for failing to yield^{*}a pedestrian. As a result, you were individually counseled on 22 Jun 89 (Tab 1-11).

1. On 23 Jun 89, you parked your POV in a non \sharp designated area. As a result, you were issued a traffic citation (Tab 1-12).

m. On 20 Jul 90, you violated Japanese road traffic law Article 22.1,4.1 (Speeding). As a result, you were counseled on 6 Aug 90 (Tab 1-13).

n. On 4 Dec 90, you operated your vehicle while drunk. As a result, you received an Article 15 on 14 Dec 90, reduction to A1C (Tab 1-14).

3. This action could result in your separation with an honorable, general or under other than honorable conditions discharge. I am recommending that you receive a general discharge. The Commander exercising SPCM jurisdiction or higher authority will make the final decision in this matter. If you are discharged, you will be ineligible for reenlistment in the Air Force.

4. You have the right to:

a. Consult legal counsel.

b. Present your case to an administrative discharge board.

c. Be represented by legal counsel at a board hearing.

d. Submit statements in your own behalf in addition to, or in flieu of, the board hearing.

e. Waive the above rights. You must consult legal counsel before making a decision to waive any of your rights.

5. You had a medical examination at the USAF Clinic, Kadena on $\frac{1}{28}$ Nov 90 at 0800 hours for the examination.

6. Military legal counsel Capt at the Area Defense Counsel at Building 1460 has been obtained to assist you. An appointment has been scheduled for you to consult him/her on 16 Jan 91, at 0800 hours. Instead of the appointed counsel, you may have another, if the lawyer you request is in the active

I will send the statements to the discharge authority with the case file to be considered with this your failure recommendation. If you fail to respond, will constitute a waiver of the right to the board hearing.
