GENERAL: The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

ISSUE: The Board finds the applicant submitted no issues contesting the equity or propriety of the discharge, and after a thorough review of the record, the Board was unable to identify any that would justify a change of discharge. The records indicated the applicant received two Article 15s for incidents of failure to go, making false official statements, and consuming alcoholic beverages while under the legal drinking age of 21. In addition, he received three Letters of Reprimand and three Records of Individual Counseling for various acts of misconduct involving being late for work and lack of good judgment. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

CONCLUSIONS: The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

1. I am recommending your discharge from the United States Air Force for minor disciplinary infractions. The authority for this action is AFPD 36-32 and AFI 36-3208, paragraph 5.49. If my recommendation is approved, your service will be characterized as honorable or general. I am recommending that your service be characterized as general.

2. My reasons for this action are:

- a. You, who knew or should have known of your duties at or near Sheppard Air Force Base, Texas, on or about 14 Dec 01, were derelict in the performance of those duties in that you willfully failed to refrain from consuming alcoholic beverages while under the legal drinking age of 21 and from consuming alcoholic beverages in the dormitory, as it was your duty to do. For your actions, you were punished under Article 15, Uniform Code of Military Justice (UCMJ), consisting of a suspended forfeiture of \$200 pay per month for 2 months, restriction to the limits of Sheppard Air Force Base, Texas for 10 days, 10 days extra duty, a reprimand, and an Unfavorable Information File (UIF) was established;
- b. On or about between 16 and 17 Mar 02, you were counseled on properly planning an out of town weekend trip because you had a problem returning on time. For your actions, you received a Record of Individual Counseling (ROIC) on 19 Mar 02;

- 3. Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising special court-martial jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force, and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force and will probably be denied enlistment in any component of the Armed Forces.
- 4. You have the right to consult legal counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult the Area Defense Counsel at Bldg 625 on 19 Feb 03 at 1300 hours. You may consult civilian counsel at your own expense.
- 5. You have the right to submit statements in your own behalf. You have 3 duty days from the date/time served to submit statements in your behalf. Any statements you want the separation authority to consider must reach me by 21 Feb 03 at //630 hours unless you request and receive an extension for good cause shown. I will send them to the separation authority.

- 7. If you fail to consult or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
