## AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2005-00037

**GENERAL:** The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

**FINDINGS**: The Board grants the requested relief.

The Board finds that neither the evidence of record nor that provided by applicant substantiates an impropriety that would justify a change of discharge. However, based upon the record and evidence provided by applicant, the Board finds the applicant's reason and authority for discharge inequitable.

**ISSUE**: Applicant does not contest his discharge. He states that since his discharge, he has been a lawabiding citizen and free of any criminal convictions and that he is advancing his professional career. The records indicated the applicant received three Letters of Reprimand and a Record of Counseling for failing a dormitory inspection, failure to obey a lawful order, unsatisfactory progress in training and for being disrespectful to an NCO. The DRB opined that this misconduct was indeed minor in nature and considered the fact that the applicant had already served four years successfully without any misconduct. They found this discharge to be too harsh.


**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

However, in view of the foregoing findings, the Board further concludes that the overall quality of applicant's service is more accurately reflected by an Honorable under the provisions of Title 10, USC 1553.

You, having knowledge of a lawful order to assist SSgt with issuing tool boxes to maintenance personnel, at Kunsan Air Base, Republic of Korea, an order it was your duty to obey, did, at Kunsan Air Base, Republic of Korea, on 8 June 1990, fail to obey the same by telling SSgt No, and also walking out on him while he was counseling you for your actions. Reference AF Form 1058, Control Roster Action, dated 22 June 1990 and Letter of Reprimand dated 12 June 1990 with attachment.
- b. You, did, at Osan Air Base, Republic of Korea, from August 1989 thru 15 February 1990, fail to progress satisfactorily in your training requirements within your assigned duties, to wit: the 36 Aircraft Maintenance Unit COSO Section. Reference Record of Individual Counseling dated 15 February 1990.
- c. You did, at Osan Air Base, Republic of Korea, on or about 3 January 1990; exhibit an extreme display of digrespect towards a noncommissioned officer to wit: you had a verbal altercation with SSgt. concerning his NCOIC; TSgt. in violation of Article 91, UCMJ. Reference letter of Reprimand dated 8 January 1990.
- d. You did; at Csan Air Ease, Republid of Korea, on or about 26 October 1989, fail to maintain minimum dormitory standards of cleanliness as required in 51 TFW regulation 90-1 and 51 Aircraft Generation Squadron dormitory standards letter dated I September 1989. Reference Letter of Reprimand dated 27 October 1989 with attachment


Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The commander exercising SPCM jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force, and if you are discharged, how your service will be characterized. If you are discharged, you will be incligible for reenlistment in the Air Force:

3. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult Capt.

Area Defence Counsel, bldg 937, room 101, on 28 Aug 90 at 0930: You may obtain civilian counsel at your own expense.

- 4. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by 30 Aug 90, 0900, unless you request and receive an extension for good cause shown. I will send them to the separation authority.
- 5. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 6. You have been scheduled for a medical examination. You must report to the Osan Air Base Hospital, on 30 Aug 90 at 0700.
- 7. Any personal information you furnish in rebuttal is covered by the Privacy Act Statement as explained in AFR 39-10, attachment 6. A copy of AFR 39-10 is available for your use in the 51 AGS Orderly Room.
- 8. Execute the attached acknowledgment and return it to me immediately.
