### AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2005-00149

**GENERAL:** The applicant appeals for upgrade of discharge to honorable.

The applicant was offered a personal appearance before the Discharge Review Board (DRB) but declined to exercise this right.

The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied.

The Board finds that neither the evidence of record nor that provided by the applicant substantiates an inequity or impropriety that would justify a change of discharge.

ISSUE: Applicant contends discharge was inequitable because it was too harsh. The records indicated the applicant received two Article 15s for misconduct. The misconduct included wrongfully possessing and consuming alcoholic beverages while under age 21, willfully destroying a dormitory wall and carpet and pulling a dormitory water fountain loose from its mounting. The records indicate that after the first incident the member was entered into the Substance Abuse Program, Track 3. He was also enrolled in a stress management program. There was no indication in the records that anyone in the chain of command was aware of the applicant's alcohol abuse at anytime prior to the first incident. The applicant had signed AF Form 2746, Substance Abuse Reorientation/Treatment Program, Memo of Understanding stating that failure of Track 3 could result in an administrative discharge. The DRB opined that through these administrative actions, the applicant had ample opportunities to change his negative behavior. The Board concluded the misconduct was a significant departure from conduct expected of all military members. The characterization of the discharge received by the applicant was found to be appropriate.

**CONCLUSIONS:** The Discharge Review Board concludes that the discharge was consistent with the procedural and substantive requirements of the discharge regulation and was within the discretion of the discharge authority and that the applicant was provided full administrative due process.

In view of the foregoing findings the Board further concludes that there exists no legal or equitable basis for upgrade of discharge, thus the applicant's discharge should not be changed.

- 1. I am recommending your discharge from the United States Air Force for a pattern of misconduct. The authority for this action is AFR 39-10, Section H, paragraph 5-47b. If my recommendation is approved, your service will be characterized as general.
- 2. My reasons for this action are:
- a. On or about 18 Dec 93, you wrongfully consumed alcoholic beverages while under the age of 21, willfully destroyed government property with damages in excess of \$100, and were drunk and disorderly as evidenced by an Article 15, dtd 1 Mar 94 (Atch 1).
- b. On or about 2 April 94, you wrongfully possessed alcoholic beverages while under the age of 21 as evidenced by an Article 15, dtd 6 Apr 94 (Atch 2).

Copies of the documents to be forwarded to the separation authority in support of this recommendation are attached. The Commander exercising SPCM jurisdiction or a higher authority will decide whether you will be discharged or retained in the Air Force and, if you are discharged, how your service will be characterized. If you are discharged, you will be ineligible for reenlistment in the Air Force.

- 3. You have the right to consult counsel. Military legal counsel has been obtained to assist you. I have made an appointment for you to consult at the state of t
- 4. You have the right to submit statements in your own behalf. Any statements you want the separation authority to consider must reach me by unless you request and receive an extension for good cause shown. OI will send them to the separation authority.
- 5. If you fail to consult counsel or to submit statements in your own behalf, your failure will constitute a waiver of your right to do so.
- 6. You have been scheduled for a medical examination. You must report to the 3rd Aerospace Medicine Squadron, Building 24-850 at 0715 on

  16 May 94. Fast (drink water only) for 14 hours prior, no alcohol 72 hours prior, no tobacco products 6 hours prior to examination, and you must be in uniform for the examination. Also, bring your eyeglasses, and contacts/contact solution if used.
