AIR FORCE DISCHARGE REVIEW BOARD DECISIONAL RATIONALE

FD-2004-00081

GENERAL: The applicant appeals for upgrade of discharge to honorable. The applicant appeared and testified before the Discharge Review Board (DRB), without counsel, at Andrews AFB on 28 Mar 2006. The following additional exhibits were submitted at the hearing: Exhibit 5(1) & 5(2): Character Reference Letters. The attached brief contains available pertinent data on the applicant and the factors leading to the discharge.

FINDINGS: Upgrade of discharge is denied. The Board finds that neither the evidence of record nor that provided by applicant justifies a change of discharge.

ISSUE: The applicant received a bad conduct discharge at a special court-martial for breaking restriction and for striking a 15-year old female in the chest with his fist. He contends that his punitive discharge is unjust and elemency is warranted because: (1) his "average conduct and efficiency ratings/behavior and proficiency mark (sic) were very good;" (2) he received awards and decorations; (3) he has been a "great citizen" since his discharge; (3) his court-martial was for "isolated or minor offenses;" (4) his court-martial punishment was harsh and disproportionate to other cases; (5) his ability to serve was impaired by his youth and immaturity; (6) he faced discrimination; (7) he was harassed by his command; (8) he was stressed; and (9) because he pled guilty for a crime he didn't commit.

The records indicated the applicant received three Article 15 actions, one Article 15 Vacation action, one Letter of Reprimand, three Letters of Admonishment and other low level counseling. The applicant's Article 15s were for theft, DUI, and assault on a female airman by striking her in the face with his fist. The records also indicated that the applicant was pending involuntary discharge for a pattern of misconduct prior to the commission of the offenses that lead to his bad conduct discharge. The command recommendation under the administrative action was that he receive an under other than honorable conditions (UOTHC) discharge.

The DRB recognized that the applicant received an Army Achievement Medal for feeding Army personnel transiting his duty station enroute to Operations DESERT SHIELD/STORM and that he received the Air Force Good Conduct Medal. The DRB also saw, however, in the applicant's three Enlisted Performance Reports (with overall ratings of 4, 3, and 3), that he while he was described variously as a "satisfactory," "good" or "excellent" duty performer, there were also negative comments on his ability to adhere to Air Force standards. The DRB also recognized that the applicant was nearly 24 years of age when he committed the offenses for which he was tried.

The DRB was not convinced that the applicant was harassed or discriminated against in light of the long list of misconduct across two different duty stations. The DRB was also not convinced that the applicant's recent assertion that he didn't commit the crime was credible in light of contrary statements in his court-martial stipulation of fact and his sworn testimony during the military judge's inquiry into the facts surrounding his guilty plea. The DRB also did not find the applicant's bad conduct discharge to be harsh or disproportionate given the nature of the offenses for which he was convicted and his previous pattern of disciplinary failures. While the DRB was disappointed to hear that the applicant had another DUI post discharge, it was pleased that the applicant was doing well and had a good job.

CONCLUSIONS: The Discharge Review Board concluded that the applicant's punitive discharge by Special Court-Martial is appropriate under the facts and circumstances of this case and there is insufficient basis, as an act of clemency, for change of discharge.

I miss it and if there's any way I can get back in the air force I will do anything to get back in. Please consider what I'm saying to you and upgrade my discharge.

- 1. I am recommending your discharge from the United States Air Force for A Pattern of Misconduct, Discreditable Involvement With Military or Civil Authorities. The authority for this action is AFR 39-10, paragraph 5-47a. I am recommending that your service be characterized as Under Other Than Honorable Conditions (UOTHC).
- 2. My reasons for this action are:
- a. On or about 18 Oct 90, you stole one pair of men's slacks, one pair of shoes, and two Nintendo home video games of a value of about \$122.00 from the Army Air Force Exchange Service at Ramstein AB, Germany. For this misconduct, you received an Article 15 resulting in reduction in grade form Amn to AB (suspended), forfeiture of \$75.00 pay per month for two months, and 30 days extra duty on 29 Oct 90.
- b. On or about 15 Nov 90, you failed to go the your appointed place of duty at the prescribed time. For this misconduct, your Article 15 suspension of reduction in grade from Amn to AB was vacated on 11 Dec 90.
- c. On 23 Jan 93, you were disruptive in the dormitory by playing your stereo at an excessively loud level. For this misconduct, you received a Letter of Reprimand on 28 Jan 93.
- d. On 25 Jan 93, you wrongfully accused an NCO of stealing \$150.00 which you claimed was secured under a piece of stereo equipment inside your stereo cabinet. For this misconduct, you received a Letter of Admonishment on 19 Feb 93.
- e. On or about 28 Feb 93, you operated a passenger vehicle while drunk. For this misconduct, you received an Article 15 resulting in reduction in grade from A1C to Amn, forfeiture of \$300.00 pay, 45 days restriction to Malmstrom AFB and 45 days extra duty on 23 Mar 93.
- f. On or about 17 Apr 93, you assaulted another airman by striking her in the face with your fist. For this misconduct, you received an Article 15 resulting in reduction in grade from Amn to AB, forfeiture of \$150.00 pay per month for 2 months, restriction to Malmstrom AFB for 45 days and 45 days extra duties on 7 Jun 93.

- 3. This action could result in your separation with an Under Other Than Honorable Conditions discharge. I am recommending that you receive an Under Other Than Honorable Conditions discharge. The commander exercising SPCM jurisdiction or higher authority will make the final decision in this matter. If you are discharge, you will be ineligible for reenlistment.
- 4. You have the right to:
 - a. Consult legal counsel.
 - b. Present your case to an administrative discharge board.
 - c. Be represented by legal counsel at a board hearing.
- d. Submit statements in your own behalf in addition to, or in lieu of, the board hearing.
- e. Waive the above rights. You must consult legal counsel before making a decision to waive any of your rights.
- 5. You must receive a medical examination. You are scheduled for a medical examination at the 43d Aerospace Medical Group at N/A hours on N/A. You recently had a medical examination on 22 Apr 93 at 0730 hours, therefore one is not required.
- 6. Military legal counsel, Area Defense Counsel, has been obtained to assist you. An appointment has been scheduled for you at 1000 of thours on 9 Jun 93 at Bldg 2050. Instead of the appointed counsel, you may have another, if the lawyer you request is in the active military service and is reasonably available as determined according to AFR 111-1. In addition to military counsel, you have the right to employ civilian counsel. The Air Force does not pay expenses incident to the employment of civilian counsel. Civilian counsel, if employed, must be readily available.
- 7. Confer with your counsel and reply, in writing, within 7 workdays, specifying the rights you choose to exercise. The statement must be signed in the presence of your counsel who also will sign it. If you waive your right to a hearing before an administrative discharge board, you may submit written statements in your own behalf. I will send the statements to the discharge authority with the case file to be considered with this recommendation. If you fail to respond, your failure will constitute a waiver of the right to a board hearing.
- 8. Any personal information you furnish in rebuttal is covered by the Privacy Act Statement as explained in AFR 39-10, Atch 6. A copy of AFR 39-10 is available for your use at the 43 MWRSS Orderly Room.
